- 7. THAT there is no case pending in a court of law, constitutional or any other legal body on the matters raised in this petition.

HEREFORE your humble petitioners pray that the senate through its relevant committee:

- 1. Deals with this petition immediately in view of the urgency and seriousness of the matters raised herein.
- 2. Investigates the circumstances that led to the nonpayment of compensation to the 28 members and any other member eligible for compensation from this project.
- 3. Recommends that the 28 members and any other person eligible for compensation along the Mwatate-Taveta –Holili road be paid immediately.
- 4. Takes any other appropriate action it deems fit.
