INVITATION TO APPEAR

TO: Hon Mohamed Abdi Mohamud, the Governor, Wajir County

WHEREAS, pursuant to Article 181 of the Constitution and section 33 of the County Governments Act, 2012, on 27th April, 2021 the County Assembly of Wajir approved a Motion for the removal from office of the Governor of Wajir County;

AND FURTHER, WHEREAS, by a letter dated 28th April, 2021 (*SPK/WCA/SENATE/4/2021(1)*), and received in the Office of the Speaker of the Senate on 29th April, 2021, the Speaker of the County Assembly of Wajir informed the Speaker of the Senate of the approval of the Motion by the County Assembly of Wajir and further forwarded to the Speaker of the Senate documents in evidence of the proceedings of the Assembly;

AND WHEREAS, pursuant to section 33(3)(b) of the County Governments Act, 2012, and standing order 75(1)(b)(i) of the Senate Standing Orders, the Senate, at a Special Sitting held on Thursday, 6th May, 2021 by Resolution, appointed a Special Committee comprising eleven of its Members to investigate the matter and to report to the Senate

within ten days on whether it finds the particulars of the allegations to have been substantiated;

AND WHEREAS, pursuant to section 33(5) of the County Governments Act, 2012 and standing order 75(3) of the Senate Standing Orders you have the right to appear and be represented before the Special Committee during its investigations;

NOW THEREFORE, the Special Committee invites you to appear and be represented before the Committee during its investigations. The first meeting of the Committee shall be held on **Wednesday, 12th May, 2021 at 10:00 a.m. at the Mini Chamber, 1st Floor, County Hall, Parliament Buildings, Nairobi**. If you choose to appear before the Committee, the Committee requires that you file, with the **Office of the Clerk of the Senate, 1st Floor, Main Parliament Buildings, Parliament Road, Nairobi, by 5:00 on p.m. Tuesday, 11th May, 2021, soft copies and TWENTY (20) hard copies** of your answer to the Particulars of the Allegations, which are annexed hereto, setting out -

- (a) your response to the Particulars of the Allegations;
- (b) how you propose to appear before the Special Committee; whether in person, by Advocate, or in person and by Advocate;
- (c) the names and addresses of the persons to be called as witnesses, if any, and witness statements containing a summary of the evidence to be presented by such witnesses before the Committee; and
- (d) any other evidence to be relied on.




