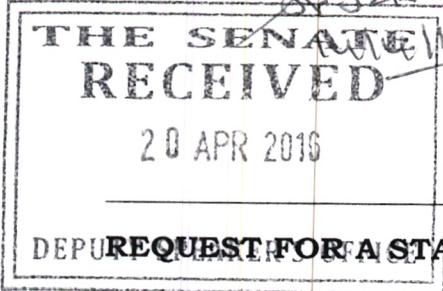

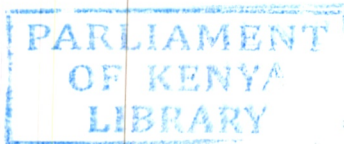
REQUEST FOR A STATEMENT ON INVASION OF BOMET POLICE STATION

Mr. Speaker Sir,

I rise Pursuant to Standing Order 45 (2) (b), to seek a Statement from the Chairperson of the Standing Committee on National Security and Foreign Relations regarding the invasion of Bomet Police Station.

In the statement, the Chairperson should-

- a) State whether the Government is aware that on 7th April, 2016, the Governor for Bomet County, led a group of people in invading Bomet Police Station;
- b) Explain the circumstances that led to the actions of the Governor;
- c) Explain whether there were any casualties and or destruction of property following the invasion;
- d) Confirm if any arrests were made;
- e) Explain the actions that have been taken against the Governor and the other perpetrators; and
- f) Confirm if both public and private property in Bomet County is properly secured and in particular the land and property belonging to Bomet Campus of Moi University.

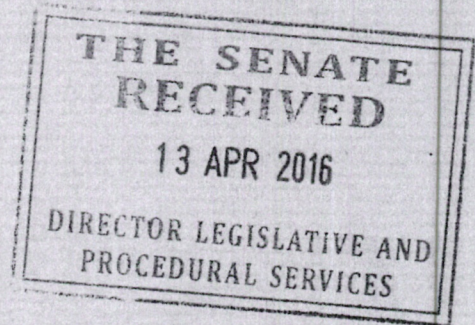
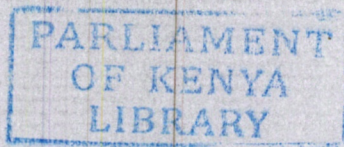
REQUEST FOR A STATEMENT

Mr. Speaker sir, pursuant to standing order no 42(1), I wish to make a personal statement on the state of affairs in Bomet County where I represent in this honorable house.

The belligerent actions and activities of the Governor of Bomet have greatly annoyed and disgraced the people of Bomet County, particularly in the recent past.

The people of Bomet are demanding answers to many questions on various diverse issues such as on Governance, resource utilization, theft and general blunder of millions of money and outright greed pertaining in the County of Bomet.

The clarion call for 'Pesa Mashinani' by the Governor of Bomet although noble is dishonest and has a silver lining of limitless greed and outright impunity. 
