### CHAIRPERSON'S FOREWORD

The petition was presented in the House by the Hon. Joseph Manje, MP on behalf of the petitioners. This is in accordance with the provisions of Standing Order No. 225 (2) (a). The petition requests the Ministry of Transport, Infrastructure, Housing and Urban Development through the Kenya National Highway Authority (KeNHA) to make Bomas-Ongata Rongai-Kiserian road into a dual carriage road to decongest it and be a relief to the people of Ongata Rongai and Kiserian areas in Kajiado North Constituency, Kajiado County.

The petition was referred to the Departmental Committee on Transport, Public Works and Housing as per the requirements of S.O. 227.

In considering the petition, the Committee held meetings with the Hon. Joseph Manje, MP, who appeared on behalf of the petitioners, and the Cabinet Secretary, Ministry of Transport, Infrastructure, Housing and Urban Development. The meetings were aimed at inquiring into and responding to the issues raised in the petition.

The Committee appreciates the assistance provided by the Offices of the Speaker and the Clerk of the National Assembly that enabled it to discharge its functions in considering the petition.

On behalf of the Committee, and pursuant to Standing Order, 227 it is my duty to table in the House the Report of the Committee on the petition.

# **EXECUTIVE SUMMARY**

In this report, the Committee has considered and responded to the prayers sought by residents of Kajiado North Constituency in a petition to make Bomas-Ongata Rongai-Kiserian road into a dual carriage road.

The main objective of making the road into dual carriage is to decongest it and be a relief to the people of Ongata Rongai and Kiserian areas in Kajiado North Constituency, Kajiado County.

The report entails presentations by the Hon. Joseph Manje, MP on behalf of residents of Kajiado North Constituency, and the Cabinet Secretary for the Ministry of Transport, Infrastructure, Housing and Urban Development. After presentations and deliberations, the Committee recommends that the Ministry should also put in place temporary measures to ensure other alternative roads near the area are passable.

# 2.0 MANDATE OF THE COMMITTEE

The Committee is established in accordance with the provisions of Standing Order No. 216, with the following terms of reference: -

- i. To investigate, inquire into, and report on all matters relating to the mandate, management, activities, administration, operations and estimates of the assigned Ministries and departments;
- ii. To study the programme and policy objectives of Ministries and departments and the effectiveness of the implementation;
- iii. To study and review all legislation referred to it:
- iv. To study, access and analyze the relative success of the Ministries and departments as measured by the results obtained as compared with their stated objectives;
- v. To investigate and inquire into all matters relating to the assigned Ministries and departments as they may deem necessary, and as may be referred to them by the House or a Minister;
- vi. To vet and report on all appointments where the Constitution or any law requires the National Assembly to approve, except those under Standing Order 204 (Committee on Appointments); and
- vii. To make reports and recommendations to the House as often as possible, including recommendation of proposed legislation.

The Committee under Standing Order 227 is also mandated to respond to the petitioner by way of a report addressed to the petitioner or petitioners and laid on the floor of the House.

The Committee oversights matters of Transport, Roads, Public works, Construction, Maintenance of roads, rails and buildings, air, seaports and housing and oversees the Ministry of Transport, Infrastructure, Housing and Urban Development

# 2.5 <u>LIST OF RECOMMENDATIONS</u>

In response to the prayers by the petitioners, the Committee recommends that:-

- 1. The Ministry of Transport, Infrastructure, Housing and Urban Development through the Kenya National Highways Authority (KeNHA) should put the Bomas-Ongata Rongai- Kiserian under the Annuity Road Development Programme.
- 2. The Bomas-Ongata Rongai- Kiserian road should be designed as a dual carriage with service lanes to decongest it.
- 3. The Ministry of Transport, Infrastructure, Housing and Urban Development should also put in place temporary measures to ensure other alternative roads near the area are passable so as to decongest the Bomas-Ongata Rongai-Kiserian road

### 3.0 INTRODUCTION

- 1. The petition by the Hon. Joseph Manje,, MP member for Kajiado North Constituency, on behalf of residents of Kajiado North Constituency regarding dualling of Bomas-Ongata Rongai-Kiserian road was tabled in the House pursuant to Standing Order 225 (2) (a) on Thursday 9<sup>th</sup> June 2016.
- 2. The main objective of making the road into dual carriage is decongest it and be a relief to the people of Ongata Rongai and Kiserian areas in Kajiado North Constituency, Kajiado County
- 3. Pursuant to the House rules, the petition was referred to the Committee on Thursday 9<sup>th</sup> June 2016 for consideration and preparation of a report within 60 days. The Committee considered the petition pursuant to the provisions of Standing Order 227.
- 4. The Petitioners drew the attention of the House to the following, that:
  - i. The Bomas-Ongata Rongai-Kserian road is a critical link between three centers and the Kajiado region as a whole;
  - ii. The road is a single lane inhibiting free movement of people, goods and services from densely populated areas;
  - iii. The continued heavy traffic jam on the peak hours has contributed to immense loss of man hours;
  - iv. Potential residents and investors of Ongata Rongai and Kiserian areas due to the heavy traffic jam have relocated to other areas denying the two areas development;
  - v. The single lane road has seen the cost of transport increase to unpredictable rates during peak hours while the time taken to cover the short distance has increased from less than thirty minutes to more than two hours which is not even assured;
  - vi. This added cost has increased expenses on the already burdened Ongata Rongai and Kiserian residents working or travelling to Nairobi; and
  - vii. The issues in respect of which this Petition is made are not pending before any Court of Law or before any Constitutional or statutory body.

- viii. The Petitioners pray that the National Assembly, through the Departmental Committee on Transport, Public Works and Housing:
  - a) Intervenes to have the Bomas-Ongata Rongai-Kiserian road into a dual carriage road to decongest it and be a relief to the people of Ongata Rongai and Kiserian areas in Kajiado North Constituency, Kajiado County.
  - b) Make any other recommendations that may be deemed fit in addressing the plight of the said residents.

## 4.0 EVIDENCE

4.1 Presentation by the Hon. Joseph Manje, MP Member for Kajiado North Constituency, on behalf of residents of Kajiado North

The Hon. Joseph Manje, MP member for Kajiado North Constituency, on behalf of residents of Kajiado North appeared before the Committee on 4<sup>th</sup> August, 2016 and informed the Committee that:-

- 1. The Bomas-Ongata Rongai-Kiserian road is a single lane inhibiting the free movement of people, goods and services from a densely populated area;
- 2. The road is a critical link between three centers and the Kajiado region as whole;
- 3. The continued heavy traffic jam on the peak hours has contributed to immense loss of man hours. Potential residents and investors of Ongata Rongai and Kiserian areas have as a result relocated to other areas denying the two areas development;
- 4. Consequently, the road has seen the cost of transport increase to unpredictable rates during peak hours, causing an increase in the time taken to cover the short distance. The added cost has increased expenses on the already burdened Ongata Rongai and Kiserian residents working or travelling to Nairobi.

# 4.2 Presentation by Eng. David Muchilwa, a representative of the Director General ,Kenya National Highways Authority (KeNHA)

Eng. David Muchilwa informed the Committee that:-

- 1. The Ministry through the Kenya National Highways Authority (KeNHA) is aware that Bomas-Ongata Rongai- Kiserian road experiences heavy traffic jam. This is attributed to the road being a two way single lane, increase in population in Ongata Rongai, mushrooming of unplanned developments next to the road without proper traffic impact studies.
- 2. The Ministry through KeNHA is undertaking the following measures in order to decongest traffic along the road:-
  - (i) On the long term, the solution for the constant traffic jam on this road, the Ministry has proposed this road to be done under Annuity Programme. The procurement process under Annuity is ongoing. The proposed design is to have this road dualed with service lanes.
  - (ii) The Ministry is also undertaking maintenance of the existing roads by patching potholes to enable traffic to flow as smoothly as possible. The tender for 2016/2017 Bomas/Ole tepesi routine maintenance works will be awarded in the month of August, 2016 once the process is finalized.

### 5.0 OBSERVATIONS

The Committee made the following observations from evidence adduced in the meetings, that:-

- 1. The Ministry through KeNHA has earmarked the Bomas-Ongata Rongai-Kiserian road to be constructed under the Annuity Programme.
- 2. The proposed design for the Bomas-Ongata Rongai- Kiserian road is to have it dualed with service lanes.
- 3. The Ministry through KeNHA is undertaking maintenance of the existing roads by patching potholes to enable traffic to flow as smoothly as possible.
- 4. The tender for 2016/2017 Bomas/Ole tepesi routine maintenance works will be awarded in the month of August, 2016 once the process is finalized.

# 6.0 <u>RECOMMENDATIONS</u>

In response to the prayers by the petitioners, the Committee recommends that:-

- 1. The Ministry of Transport, Infrastructure Housing and Urban Development through the Kenya National Highways Authority (KeNHA) should put the Bomas-OngataRongai- Kiserian under the Annuity Road Development Programme.
- 2. The Bomas-Ongata Rongai-Kiserian road should be designed and constructed as a dual carriage with service lanes to decongest it.
- 3. The Ministry of Transport, Infrastructure, Housing and Urban Development should also put in place temporary measures to ensure other alternative roads near the area are passable so as to decongest the Bomas-Ongata Rongai- Kiserian road

## **Preliminaries**

The Chairperson called the meeting to order at 10:30 am. A prayer was said followed by introductions.

MIN/DC-TPWH/2016/161 Consideration of various petitions before the Committee

Petition by the Hon. Kubailringo, MP on behalf of residents of Igembe Central Constituency

The Chairperson invited thepetitioner, the Hon. Kubai Iringo, M.P. to make his submissions before the Committee.

He informed the Committee that his petition, presented on behalf of residents of Igembe Central Constituency had been occasioned by dilapidated state of the 28-kilometer section of road from Farm (along Meru Maua Road) to Murera Gate (Meru National Park) which was tarmacked about twenty (20) years ago, after which it has not been regularly maintained thereby degenerating into a deplorable state, particularly after the recent El-Nino rains.

He further noted that the impassable state of the road has drastically reduced inflow of tourists in the Meru National Park and cut off residents from accessing markets for their farm produce, consequently stagnating economic growth and escalating of poverty among residents who depend on agriculture and tourism.

He also noted that in 2014, a valuation done by engineers from Meru National Park and the Kenya Rural Roads Authority (KeRRA) estimated the cost of re-carpeting the road at Ksh. 75,000,000 and that out of this, the Ministry had only disbursed Ksh. 5,000,000 without any indication on whether the balance would be available and when it would be disbursed.

In response, the Director General, KeRRA informed the Committee that the Ministry was aware of the deplorable state of the road which is in urgent need of repairs. He however noted that prioritization of maintenance for roads in the Constituencies is the responsibility of the Constituency Roads Committees (CRC's) as per the Finance Act, 2009. The Road Maintenance Levy Fund (RMLF) allocated to KeRRA is shared equally amongst the Constituencies, and therefore, the Authority has no extra funds for roads maintenance.

Further, he noted that due to the huge financial outlay required to maintain bitumen roads, most CRC's across the country have not been prioritizing their maintenance leading to continued deterioration.

In view of the above, KeRRAhas been working on a strategy to maintain its bitumen road network, which will require additional financing for maintenance of paved road network from the National Treasury.

The Committee was further informed that the Farm to Murera Gate (Meru National Park) road will be one of the roads to be included in the aforementioned strategy.

It was resolved that an allocation from the emergency fund under the Cabinet Secretary, Ministry of Transport, Infrastructure, Housing and Urban Development be given to KeRRA to enable the Authority deal with such maintenance works.

Petition by the Hon. Peter Weru, MP on behalf of residents of Magutu and Iriaini Wards in Mathira Constituency

The Chairperson invited the petitioner, the Hon. Peter Weru, M.P. to make his submissions before the Committee.

He informed the Committee that the road loop connecting Karatina town via Ihwagi, Giakaibei, Kagochi to Karatina University and the sections through Gitunduti, Gaikuyu to Karatina Hospital has over time degenerated to an impassable state, causing traffic snarlups in the area. The poor state of the road has been blamed for causing five fatal accidents that have occurred along the road in the past two months.

The Committee further heard that at the beginning of 2016, the Cabinet Secretary in the Ministry of Transport, Infrastructure, Housing and Urban Development undertook to allocate Ksh. 307,000,000 for re-carpeting the dilapidated tarmacked section and upgrade the earthen section to bitumen standards but the process is yet to commence.

He thus sought to find out the circumstances behind the delay in disbursement of the funds meant for construction of the road.

In response, the Director General, KeRRA informed the Committee that the Ministry through KeRRA was not aware of a commitment by the Cabinet Secretary to allocate Ksh. 307,000,000 to re-carpet the dilapidated tarmacked section of the road.

Further, that the Road Karatina – Jambo – Ihwagi – Gikaibei – Kagochi – Gitunduti– Gaikuyu – Karatina Hospital is approximately 28.5 kms. It is divided into three sections namely Karatina – Jambo – Kagochi is 12.3 Km which is tarmacked but not in a satisfactory state. However, it has been earmarked for rehabilitation under the Roads 10,000 km Low Volume Seal (LVS) programme. The procurement for this section is underway.

The second section is Kagochi – Karatina University – Gitunduti which is 4.2 km. This section is gravelled and is currently in a fairly good condition. It is proposed for upgrading to bitumen standards under the Development Partner AFD funded R 2000 Low Volume Seal (LVS) program. It is envisioned that road works will commence this financial year 2016/2017.

The third section is Gitunduti – Gaikuyu – Karatina Hospital which is approximately 12 Km long is graveled and in a fair condition. This section has also been proposed for upgrading to bitumen standards under the R 10,000 Km LVS program, and procurement for road works is also ongoing.

The Hon. Peter Weru, MP was however concerned that the Ministry was not aware of the commitment by the Cabinet Secretary to allocate Ksh. 307,000,000 for construction of the road. The Director General, KeRRA however clarified that the allocation was done not long ago.

It was resolved that since the procurement processes for the construction of the various sections were underway, the Ministry, through KeRRa should fast track the process and give feedback to the Hon. Peter Weru, MP regarding the proposd commencement dates of construction works.

Petition by the Hon. Joseph Manje, MP on behalf of residents of Kajiado North Constituency, Kajiado County

The Chairperson invited the petitioner, the Hon. Joseph Manje, M.P. to make his submissions before the Committee.

He informed the Committee that the Bomas-OngataRongai-Kiserian road is a single lane inhibiting the free movement of people, goods and services from a densely populated area.

As a result, the road has seen the cost of transport increase to unpredictable rates during peak hours, causing an increase in the time taken to cover the short distance. The added cost has increased expenses on the already burdened OngataRongai and Kiserian residents working or travelling to Nairobi.

He thus sought to find out when the Ministry, through the Kenya National Highways Authority (KeNHA) would have the section of the road made into a dual carriage road to decongest it.

In response, the General Manager (Special Projects), KeNHA noted that the Ministry through KeNHA is aware that Bomas-OngataRongai- Kiserian experiences heavy jam. This is attributed to the road being a two way single lane, increase in population in OngataRongai, mushrooming of unplanned developments next to the road without proper traffic impact studies.

In view of the above, the Ministry through KeNHAwas undertaking the following measures in order to decongest traffic along the road:-

- a) On the long term, the solution for the constant traffic jam on this road, the Ministry has proposed this road to be done under Annuity Programme. The procurement process under Annuity is ongoing. The proposed design is to have this road dualed with service lanes.
- b) The Ministry is also undertaking maintenance of the existing roads by patching potholes to enable traffic to flow as smoothly as possible. The tender for 2016/2017 Bomas/Ole tepesi routine maintenance works was scheduled to be awarded in August, 2016 once the process is finalized.

The Hon. Joseph Manje, MP proposed that in the meantime, alternative routes could be tarmacked to allow traffic access the routes.

The Director General, KeRRA noted that consultation were underway with the Ministry to have alternative routes tarmacked.

The Committee further raised concern over the commencement of the Annuity Program and the progress of the Low Volume Seal (LVS) roads program saying that the Ministry should provide a supplementary answer detailing the progress of both programs.

# Petition by the Hon. KhatibMwashetani, MP on behalf of residents of Lungalunga Constituency

The Chairperson invited the petitioner, the Hon. KhatibMwashetani, M.P. to make his submissions before the Committee.

He informed the Committee that the Ministry, through KeNHA had issued an eviction and demolition notice to land and business owners in regards to buildings erected along the Likoni-Lungalunga (A14) road reserve, especially at Kanana area.

The Committee further heard that the buildings in question were constructed on legally acquired land and land owners are in procession of valid allotment letters from the Ministry of Lands, and that some of the buildings marked for demolition are located more than 20 meters from the road reserve and are thus not eligible for demolition and/or eviction.

He therefore sought to find out the intended timelines for the evictions and/or demolitions by the Ministry since the residents were unsettled by the intended move by the Ministry.

In response, the General Manager (Special Projects), KeNHA informed the Committee that the Likoni-Lunga Lunga Road is classified as A7 (formerly A14). Currently there is routine maintenance works ongoing between Likoni and Lunga Lunga and periodic maintenance works between Ukunda and Lunga Lunga. The engineering design of the road has been finalized under the Multinational Malindi-Mombasa-Lunga Lunga Bagamoyo project to be funded by the African Development Bank.

The Resettlement Action Plan (RAP) detailing the extent of land acquisition necessary for the road expansion and particulars of the project-affected-persons (PAPS) has been finalized and that due process shall be followed in dealing with land acquisition and project affected persons (PAPs) before the commencement of the expansion works.

Currently, the Governments of Kenya and Tanzania are jointly working out the financing arrangements under the auspices of the East African Community (EAC) before the project implementation plan is drawn up and thus no demolitions have been sanctioned in connection with the proposed expansion of Likoni-LungaLunga road. Further, no demolitions shall be carried out without fair compensation to the project affected persons (PAPs). He assured that the Authority will engage the stakeholders and identified PAPs in consultations prior to implementation of the project.

The owners of emerging encroachments within the road reserve along the said road are routinely served with notices to vacate to enhance functionality and level of service of the road. Currently, KeNHA has no plans to demolish any buildings along the said road.

Petition to the National Assembly seeking Amendment to National Transport and Safety Authority Act to introduce Road Safety Branding and Establishment of National Road Safety Insurance Fund by a Member of Public, Mr. Blamuel Njururi

The Chairperson invited the Director General in the National Transport and Safety Authority (NTSA), Mr. Francis Meja to give submissions to the Committee on the Ministry's position with regards to the petition. Mr. Meja informed the Committee as follows:

- 1. With regards to Road Safety Branding, the Committee was informed that the NTSA Act in section 4 includes the development and implementation of Road Safety Strategies as well as public education as part of its functions. Specifically Section 4(2)(d) provides as follows:
  - i. In the performance of its functions under subsection (1), the Authority shall-.
  - ii. (d) develop and implement road safety strategies;
  - iii. (e) facilitate the education of the members of the public on road safety;
- 2. He noted that the above is an overarching provision that encompasses all road safety strategies including road safety branding and that it was not possible to legislate all the road safety strategies as they are not only infinite but by doing so this would limit the Authority's mandate in terms of development of new safety strategies.
- 3. The amendment of the NTSA Act to legislate road safety branding is therefore not prudent and the Authority consequently objected to it.
- 4. On the issue of Commercial Vehicle Branding, the Committee heard that the Authority had developed draft Regulations on the Operation of Commercial Vehicles 2016 which were submitted for public participation through the local

dailies. The regulations are aimed at regulating all aspects of the operations of these vehicles; the issue of reflective branding had also been included wherein it had been made mandatory for commercial vehicles to have reflective markings to outline not only the rear and sides as proposed by the petitioner but the front as well.

- 5. With regards to the introduction of a National Road Safety Insurance Fund, the Committee was informed that this shall have a substantial effect on the premiums payable by motorists including public and commercial vehicles and therefore a substantive increase in the cost of the movement of goods and services. Further, that any attempt to create the fund should be done through the Insurance Regulatory Authority in consultation with the National Treasury and not the NTSA.
- 6. Section 47 of the NTSA Act establishes a National Transport and Safety Fund as follows:-
  - 47. (1) There is established a Fund to be known as the National Road Transport

and Safety Fund which shall vest in the Authority.

- (2) There shall be paid into the Fund:-
  - (a) moneys appropriated by Parliament;
  - (b) the levy;
  - (c) grants and donations made to the Authority; and
  - (d) moneys from a source approved by the Authority.
- (3) The Authority shall apply the moneys received into the Fund to-
  - (a) conduct research activities and audits on road transport safety;
  - (b) conduct road safety education and awareness campaigns;
  - (c) implement road safety strategies; and
  - (d) carry out the operations of the Authority.
- (4) The Authority shall apply the moneys received into the Fund to-
  - (a) conduct research activities and audits on road transport safety;
  - (b) conduct road safety education .and awareness campaigns;

- (c) implement road safety strategies; and
- (d) carry out the operations of the Authority.

The Ministry's view was that the matters petitioned i.e. road safety branding, commercial vehicle branding and creation of a Fund are already catered for in the NTSA Act.
