CHAIRPERSON'S FOREWORD

Standing Order 200A (1) and (2) of the National Assembly provides that, "a Committee which is unable to complete its work before the expiry of its term shall table an exit report to the Assembly detailing reasons for such inability; and (2) "The report shall be made available to the succeeding Committee which may consider it in preparing its work plan."

The report highlights the activities undertaken by the Departmental Committee on Energy in the Twelfth Parliament from the period the Committee was constituted in November 2017 until June 2022, covering six sessions in total. The Committee has executed its mandate in line with the National Assembly Standing Orders No. 216 which includes consideration and processing legislation referred to it; exercise oversight over the Ministries of Energy and Petroleum and Mining as well as their respective Semi-Autonomous Government Agencies (SAGAs) reporting to it; considering international agreements referred to it, scrutinize the budget vote of the Ministry of Energy and that of Petroleum and Mining as well as their SAGAs; facilitating public participation in its processes; and to consider all other matters referred to it in terms of Questions, Petitions, Motions and legislations and the Rules of Parliament.

In total, the Committee considered fifty-eight (58) Questions, seven (7) Petitions, three Bills (3), Twenty-nine (29) inspections and fact-finding visits, seven statements (7), one inquiry and seven (7) capacity building activities.

This report enumerates the key achievements attained by the Committee and has indicated the pending business that may form the basis of the work program of the Committee to be established in the 13th Parliament.

The Committee wishes to thank the Offices of the Speaker and the Clerk of the National Assembly for the logistical and technical support over this period of the Twelfth Parliament and pursuant to provisions of Standing order 200A (1), it is my pleasant duty to Table in the House the Exit Report of the Departmental Committee on Energy.

 - iii) study and review all legislation referred to it;
 - iv) study, assess and analyze the relative success of the Ministries and departments as measured by the results obtained as compared with their stated objectives;
 - v) investigate and inquire into all matters relating to the assigned Ministries and departments as they may deem necessary, and as may be referred to them by the House;
 - vi) to vet and report on all appointments where the Constitution or any law requires the National Assembly to approve, except those under Standing Order 204 (Committee on Appointments);
 - vii) examine treaties, agreements and conventions;
 - viii) make reports and recommendations to the House as often as possible, including recommendation of proposed legislation;
 - ix) make reports and recommendations to the House as often as possible, including recommendation of proposed legislation;
 - x) consider reports of Commissions and Independent Offices submitted to the House pursuant to the provisions of Article 254 of the Constitution; and
 - xi) examine any questions raised by Members on a matter within its mandate.
- 2. In accordance with the Second Schedule of the Standing Orders, the Committee is mandated to consider matters relating to the Fossil Fuel Exploration, Development, Production, Maintenance and Regulation of Energy.
- 3. The Second Schedule to the Standing Orders mandates the Committee to consider matters relating to the Fossils fuels exploration, Development, production, maintenance and regulation of energy.
- 4. In executing this mandate, the Committee oversees the following Ministries, Department and Agencies (MDAs):
 - i. The Ministry of Energy; and
 - ii. The Ministry of Petroleum and Mining (State Department for Petroleum).





2.9 BUDGETARY REVIEW

23. The Committee in undertaking budget-making role reviewed budget documents i.e., Budget Policy Statements for FYs 2018, 2019, 2020, 2021 and 2022, budget estimates for FYs 2018/19, 2019/20, 2020/21, 2021/22 and 2022/23 and Supplementary Estimates that were submitted to the House for consideration during the period.

PART THREE

3.0 ACHIEVEMENTS

24. The Committee over this period, while carrying out its oversight mandate, saw the Ministry of Energy and its agencies implement the following critical projects in the country;

(i) Last Mile Connectivity and provision of transformers in constituencies

The project aims at facilitating the objective of affordably connecting Kenyan households to the national network grid. This has led to;

- a) Improved rural electricity connectivity and reduction in fixed charges.
- b) Enhanced Small Medium size (SMEs) performances with the access to electricity and allowed for growth of more SMEs in rural areas e.g., posho mills, farm produce cold storages etc.
- c) Increased availability of medical facilities and schools especially boarding schools because of the availability of electricity.
- d) Increased time for education of children especially the girl child and the rural boy child as they can finish their chores and do homework and study
- e) Increased productivity of the women as it allows them to work at night, use electricity to pump water from boreholes and therefore free time to engage in other productive activities and family time.
- f) The increased use of electricity will also reduce the need for kerosene and therefore fossil fuels and use of firewood and so contribute towards conservation of the climate and reduction in climate change.
- g) The jua kali sector has been opened up in rural areas for instance, welding and production of metal doors and grills has percolated to the smaller rural villages which saves time, energy to seek the same services in the larger towns.
- h) There is better and continuous communication as the phones can be charged at home and not at the centres as was the case before. Sports and cultural activities can be scheduled for the night.
- i) With electricity, there is more access to other forms of media including television and radio whose dissemination of information is real time.

(ii) Street lighting project

The project aims to ensure there is sufficient street lighting in areas of human settlement to enhance security, promote a 24-hour economy and increase productivity. This has led to: -

- a) Improved security and the number of hours people can be productively engaged. This includes vulnerable persons' access to toilets and medical centres at night. There is also increased safety on roads and bus terminus for travellers.
- b) Market hours have been extended which means more money in people's pocket. Further, traders just secure their wares in the market place instead of incurring cost to transport them to secure places and possible damages and losses.
- (iii) The change of the energy mix with more emphasis on green energy sources. There is more emphasis on renewable energy sources like solar, geo-thermal and wind. This

will reduce the dependency on hydro generation which in turn reduces the increased cost of power generation during time of drought because the generating company is forced to use diesel due to the reduced water levels. The increased addition of electricity generated through green energy sources instead of fossil will go a long way to reducing the impact on climate change.

- (iv) The Committee plans to ensure that the prices of power further reduce to assist in manufacturing competitiveness as the cost of power in Kenya is very high.
- (v) Handling and successfully disposing off two (2) petitions which responded to issues of concern to the people as envisaged in article 95 (2) of the Constitution.
- (vi) Processing of Bills which were ultimately enacted into following Acts of Parliament:
 - a) Energy Act No. 1 of 2019 which is an act of Parliament to consolidate the laws relating to energy, to provide for National and County Government functions in relation to energy, to provide for the establishment, powers and functions of the energy sector entities; promotion of renewable energy; exploration, recovery and commercial utilization of geothermal energy; regulation of midstream and downstream petroleum and coal activities; regulation, production, supply and use of electricity and other energy forms; and for connected purposes. This legislation has consolidated all laws relating to energy by repealing both Energy Act No.12 of 2006 and Geothermal Resources Act No.12 of 1982 of laws of Kenya. Further, this Act has also aligned the legal and regulatory framework of the energy sector to be in line with the Constitution of Kenya, 2010. This Act has provided for the following:
 - i. Provided clarity on roles of National and County Governments.
 - ii. Ended the monopoly of Kenya Power as the only Off taker of power in this country by allowing licensing of other entities to undertake power distribution.
 - iii. imposed local content requirements on energy projects and the local content plans which should ensures that: first consideration is given to services provided within the County and goods manufactured in Kenya, where the goods meet the relevant specifications; qualified and skilled Kenyans are given first consideration with respect to employment at all levels of the value chain; and adequate provision is made for the training of Kenyans on the job.
 - iv. Provided for an Energy and Petroleum tribunal to hear and resolve disputes arising from execution of the Act.
 - v. Has established REREC which in addition to rural electrification, will provide policy formulation, research and development, international cooperation and the promotion of renewable energy use amongst the local population.
 - vi. It has established RERAC an inter-ministerial committee intended to advise the responsible CS, Energy on the allocation of renewable energy resources, the licensing of renewable energy resource areas, the management of water towers and catchment areas, the development of multi-purpose projects such as dams and reservoirs and the management and development of renewable energy resources.
 - vii. Established Nuclear Power and Energy Authority which among its roles is to develop and implement Kenya's Nuclear Power program which

- can be used for cancer treatment, enhance Kenya's move towards green energy, Agriculture, electricity and heat generation.
- viii. Compensation for damage to property as a result of power outages.
- ix. Payment of loyalties to the County Government and the local Community for geothermal, wind and solar sources of energy generation.
- b) Petroleum Act No.2 of 2019 is an act of Parliament to provide a framework for the contracting, exploration, development and production of petroleum; cessation of upstream petroleum operations; to give effect to relevant articles of the Constitution in so far as they apply to upstream petroleum operations, regulation of midstream and downstream petroleum operations; and for connected purposes. Kenya in 2009 discovered hydrocarbons (crude oil) in Turkana County and as result there was need to have laws that would guide Oil exploration activities Kenya. Therefore, the Committee facilitated the enactment of the Petroleum Act, 2017.  - iii. Profit sharing between the National Government, County Government and Local Community on the resources.
- c) Nuclear Regulatory Act No.29 0f 2019 is an act of Parliament to provide for a comprehensive framework for the regulation of safe, secure and peaceful utilization of atomic energy and nuclear technology; the production and use of radiation sources and the management of radioactive waste; the repeal of the Radiation Protection Act and for connected purposes.
- (vii) Processing responses to several questions from different members relating to electricity connectivity to public facilities, schools, markets and health facilities has led to increase connectivity in these places which in turn has improved the public lives and productivity.
- (viii) Inquiry into the variance in the purchasing cost of power by Kenya Power and Lighting Company (KPLC) from Kenya Electricity Generating Company (KenGen) and Independent Power Producers (IPPs) which arose from a statement sought by the Member for Garissa Township Hon. Aden Duale, MP on the matter. The Committee conducted an inquiry into the rate that KenGen and IPPs supply generated electricity to Kenya Power; the basis of the differences in the rates charged by each IPP and KenGen, the list of directors and shareholders of the IPPs, the monies thus paid to each IPP by the Ministry of Energy and Kenya Power since the start of the respective contracts.
- (ix) In considering the Budget Policy Statements and the Budget Estimates for the energy and petroleum sectors for the Fiscal Years 2019/20, 2020/21 and 2020/22, the Committee recommended allocation of funds to several areas under its mandate.

- i. Power transmission and distribution to ensure that power generated is distributed. This is in line with the change in policy in reducing power generation and increasing infrastructure and facilitating connectivity to increase distribution.
- ii. Allocation to Last Mile Connectivity projects across the Country especially in rural areas to allow for more customers to be connected with electricity. This has increased distribution network in the Country. This includes provision of transformers and their maximization.
- iii. Geothermal wells exploration for instance by National Oil Corporation and Geothermal Development Company in order to increase the green energy forms of electricity generation (steam, solar, wind etc.)

Other Matters

- 25. The Committee has also under its own initiative examined
 - i. The financial status of National Oil Corporation with an aim of assisting the institution improve its financial situation either through legislation and increased budget allocation.
 - ii. The delineation of a State Corporation Board of Directors mandate and the Corporation Senior management to ensure clear roles and mandate are provided for and followed to enhance accountability for instance Kenya Pipeline and Kenya Power.

PENDING BUSINESS

- 26. Pending business before the Committee as of 9th June 2022 includes the following:
 - i. Inquiry into the purchase of power conducts an inquiry into the variance in costs of purchasing power by *Kenya Power and Lighting Company (KPLC) from Kenya Electricity Generating Company PLC (KenGen) and Independent Power Producers*. The matter has since been overtaken by completion and ongoing implementation of a report by a taskforce appointed by the Executive on the same. The succeeding Committee in the 13th Parliament may ensure full implementation of the recommendations;
 - Joint inquiry with Delegated Legislation on the matter of petroleum pricing ii. parameters used by the Energy and Petroleum Regulatory Authority (EPRA). This arose from a statement sought by the Member for Mvita Constituency, Hon. Abdulswamad Sheriff Nassir, MP on the matter. The House resolved that the Committee conducts a joint inquiry into the pricing parameters used by the Energy and Petroleum Regulatory Authority (EPRA) in determining the maximum wholesale and retail petroleum prices in the country. Further to engage EPRA to explore avenues of revising the petroleum pricing parameters that are anchored on Energy (Petroleum Pricing) Regulations 2010 and the Energy, (Petroleum Pricing) (Amendment) Regulations 2012. This is with a view to making recommendations to the House that may lead to amendments to existing delegated legislation. Sub-Committees from each Committee were yet to be formed to undertake the inquiry. However, on a related petition on operations of the Open Tender System, the Committee recommended that the Ministry submits Regulations envisaged under Section 101 (d) of the Petroleum Act, by 31st December 2022.

PART FOUR

4.0 CHALLENGES AND RECOMMENDATIONS

- 1. During the Twelfth Parliament, the Committee encountered the following challenges:
 - a) Slow or inadequate implementation of the Committee's recommendations mainly due to inadequate or lack of resources. There is need for the government to prioritize resources on areas where Kenyans are likely to experience immediate gains from its services as guided by the resolutions of the House.
 - b) The Ministry of Energy officials severally did not honour invitations and summons from the Departmental Committee on Energy. This led to deferment of business before the Committee thus hindering Members from prosecuting Questions, Petitions, Motions and legislation relating to the Energy Sector in a timely manner.
 - c) The Ministry of Energy and its related parastatal and agencies on several occasions gave unsatisfactory responses with regards to Members Question, petitions, motions and legislation relating to the Energy Sector. This delayed the timely tabling of reports by the Committee to the House;
 - d) Difficulty in the prioritization of business pending before the Committee arising from the serious challenges that faced the Energy sector in 2018.
 - e) Increased number of generic questions received by Committee for instance questions regarding status of last mile activities in the constituencies which has led to crowding out the required time to undertake meaningful oversight.
 - f) The COVID-19 pandemic posed a challenge to the National Assembly and its Committees leading to a reduction in sittings for the better part of 2020. However, the House embraced digital technology in particular virtual sittings and hybrid meetings to accommodate Members who could not attend physical meetings;
 - g) The advent of digital technology posed a further challenge as Members of Parliament were unprepared to adapt to virtual applications such as zoom hence there was inadequate interaction and slow adaptation to virtual meetings;
 - h) Administrative challenges specifically insufficient infrastructure impacted negatively on the effectiveness of the Committee work.
