#### CHAIRPERSON'S FOREWORD

This report contains the Committee's proceedings on consideration of the Regional Development Bill (National Assembly Bill No. 46 of 2021) 2021 sponsored by Hon. Katoo Ole Metito, MP, then the Committee's Chairperson. The Bill was read a First Time on Wednesday, 16<sup>th</sup> February, 2022 and immediately committed to the Departmental Committee on Defence and Foreign Relations for review and reporting to the House pursuant to the provisions of National Assembly Standing Order 127.

The Bill seeks to consolidate the laws relating to regional development and to provide for the establishment, powers and functions of the six (6) existing regional development bodies. These are Coast Development Authority, Ewaso Ng'iro North River Basin Development Authority, Ewaso Ng'iro South River Basin Development Authority, Kerio Valley Development Authority, Lake Basin Development Authority, Tana and Athi Rivers Development Authority.

The Committee called for memoranda from the public pursuant to Article 118(1)(b) of the Constitution and Standing Order 127(3) and received responses from one stakeholder. The Committee discussed the Bill with the Ministry of East African Community and Regional Development Authorities on 1<sup>st</sup> March, 2022 and 1<sup>st</sup> April, 2022. The Committee's recommendations and schedule of amendments are contained Part IV of the Report.

The Committee is grateful to the offices of the Speaker and Clerk of the National Assembly for the logistical and technical support accorded to it during its consideration of the Bill. The Committee further wishes to thank all stakeholders who made submissions on the Bill. Finally, I wish to express my appreciation to the Honourable Members of the Committee and the Committee Secretariat who made useful contributions towards consideration of the Bill and ultimate production of this report.

On behalf of the Departmental Committee on Defence and Foreign Relations and pursuant to provisions of Standing Order 199 (6), it is my pleasant privilege and honour to present to this House the Committee's report of the Committee on the Regional Development Authorities Bill, 2021. It is my pleasure to report that the Committee has considered the Regional Development Authorities Bill, 2021 and has the honour to report back to the National Assembly with the recommendation that the Bill should be approved with amendments.

#### **PART I**

#### 1.0 PREFACE

#### 1.1 Establishment and Mandate of the Committee

- 1. The Departmental Committee on Defence and Foreign Relations is established under Standing Order No. 216. Its mandate pursuant to SO 216 (5) with the following terms of reference;
  - i) investigate, inquire into and report on all matters relating to the mandate, management, activities, administration, operations and estimates of the assigned Ministries and Departments;
  - ii) study the programme and policy objectives of the Ministries and Departments and the effectiveness of the implementation;

#### PART II

#### 2.0 OVERVIEW OF THE REGIONAL DEVELOPMENT AUTHORITIES BILL, 2021

- 6. The Bill seeks to consolidate the laws relating to regional development and to provide for the establishment, powers and functions of the six (6) existing regional development bodies. These are Coast Development Authority, Ewaso Ng'iro North River Basin Development Authority, Ewaso Ng'iro South River Basin Development Authority, Kerio Valley Development Authority, Lake Basin Development Authority, and Tana and Athi Rivers Development Authority.
- 7. The Bill standardizes the functions of regional development authorities subject to the unique areas of operation of each regional development authority. It further standardizes the membership of the Boards of each regional development authority to eleven (11) members in line with best practices in corporate governance.
- 8. The Bill has seven parts. These are preliminary, establishment of regional development authorities, administration of regional development authorities, financial provisions, provisions on delegated powers, miscellaneous provisions, and savings, transitional and repeal.
- 9. Part I provides for the preliminary provisions.
- 10. Clause 3 provides for the general principles to guide implementation of the Act.
- 11. Clause 4 provides for the regional development strategy. It provides that the Cabinet Secretary shall formulate and publish a regional development strategy at least once every ten years, to guide the protection, conservation, development and regulation of the country's basin based natural resources.
- 12. Part II provides for the establishment of Regional Development Authorities.
- 13. Under this part, the Bill provides for the establishment of the Coast Development Authority, Ewaso Ng'iro North River Basin Development Authority, Ewaso Ng'iro South River Basin Development Authority, Kerio Valley Development Authority, Lake Basin Development Authority, Tana and Athi Rivers Development Authority.
- 14. Clause 5 provides for the establishment of the Coast Development Authority. Clause 6 provides for the composition of the Board of the Authority consisting of 11 members. Clause 7 provides for the functions of the Authority. Clause 8 provides for the Managing Director of the Authority.
- 15. Clause 9 provides for the establishment of the Ewaso Ng'iro North River Basin Development Authority. Clause 10 provides for the composition of the Board of the Authority consisting of

- 11 members. Clause 11 provides for the functions of the Authority. Clause 12 provides for the Managing Director of the Authority.
- 16. Clause 13 provides for the establishment of the Ewaso Ng'iro South River Basin Development Authority. Clause 14 provides for the composition of the Board of the Authority consisting of 11 members. Clause 15 provides for the functions of the Authority. Clause 16 provides for the Managing Director of the Authority.
- 17. Clause 17 provides for the establishment of the Kerio Valley Development Authority. Clause 18 provides for the composition of the Board of the Authority consisting of 11 members. Clause 19 provides for the functions of the Authority. Clause 20 provides for the Managing Director of the Authority.
- 18. Clause 21 provides for the establishment of the Lake Basin Development Authority. Clause 22 provides for the composition of the Board of the Authority consisting of 11 members. Clause 23 provides for the functions of the Authority. Clause 24 provides for the Managing Director of the Authority.
- 19. Clause 25 provides for the establishment of the Tana and Athi Rivers Development Authority. Clause 26 provides for the composition of the Board of the Authority consisting of 11 members. Clause 27 provides for the functions of the Authority. Clause 28 provides for the Managing Director of the Authority.
- 20. Part III of the Bill provides for the administration of regional development authorities.
- 21. Clause 29 provides that the conduct and regulation of the business and affairs of the Boards of each regional development authority shall be as provided in the Schedule.
- 22. Part IV of the Bill provides for financial provisions.
- 23. Part V provides for provisions on delegated powers. Clause 38 provides that the Cabinet Secretary may make regulations to provide for—
  - (a) any matter which is required or permitted by this Act to be prescribed by regulations;
  - (b) the management and sustainable development and utilization of basin based natural resources;
  - (c) forms under this Act;
  - (d) matters of procedure in relation to any application under this Act; and
  - (e) any other matter which is necessary or expedient to prescribe in order to achieve or promote the objects of this Act.
- 24. Part VI provides for miscellaneous provisions.

25. Part VII provides for savings, transition and repeal. In particular, clause 44 repeals the Kerio Valley Development Authority Act, the Lake Basin Development Authority Act, the Tana and Athi Rivers Development Authority Act, the Ewaso Ng'iro South River Basin Development Authority Act, the Ewaso Ng'iro North River Basin Development Authority Act, and the Coast Development Authority Act.

#### **PART III**

#### 4.0 PUBLIC PARTICIPATION/ STAKEHOLDER ENGAGEMENT

- 26. Following call for memoranda from the public through the placement of advertisements in the print media on 22<sup>nd</sup> February, 2022 requesting for comments from the public on the Bill.
- 27. The Committee received memoranda from the Ministry of East African Community and Regional Development. This is provided for below.

#### LONG TITLE

- 28. The Ministry of East African Community and Regional Development proposed that the long title should be amended by deleting the word "bodies" and to insert the word "Authorities".
- 29. The justification for the proposed amendment was that it will streamline the operations of Regional Development Authorities under a singular Act and align their operations and objectives with the Constitution of Kenya, 2010.

#### **SHORT TITLE**

- 30. The Ministry of East African Community and Regional Development proposed an amendment to the short title to, "This Act may be cited as the Basin Based Development Authorities Bill, 2021".
- 31. The justification for the proposed amendment is that the proposed short title aligns with the functions and mandate implemented by the Regional Development Authorities without creating any confusion with other agencies or county governments.

#### **CLAUSE 2**

- 32. The Ministry of East African Community and Regional Development proposed that Clause 2 be amended by amending the definition "Lake Basin" as follows—
  - "Lake Basin" means Lake Victoria catchment area and drained area and bounded by water sheds of the Nzoia, Yala, Nyando, Sondu, Kuja and their tributaries draining to Lake Victoria.
- 33. The justification for the proposed amendment is that it is an elaborate definition of Lake Basin.

#### **CLAUSE 6,10,14 & 18**

- 34. The Ministry of East African Community and Regional Development proposed that the clauses should be amended to provide for the composition of the Board to include:
  - (a) Chairperson, appointed by the President;
  - (b) Principal Secretary responsible for regional development authorities;
  - (c) Principal Secretary responsible for finance;

- (d) Principal Secretary responsible for environment;
- (e) Five other persons appointed by the Cabinet Secretary.
- 35. The justification for the proposed amendments is that the proposals align with Mwongozo Guideline on the composition of numbers which should be between 7-9 members. The Committee Bill has proposed an eleven-member Board which exceeds Mwongozo Guidelines.

#### CLAUSE 6(3), 10(3), 14(3) AND 17 (3)

- 36. The Ministry of East African Community and Regional Development proposed that the clauses should be amended to prescribe extensive qualifications for both the chairperson and the non-government Board members which include degree qualification; have at least fifteen years' experience in the management of public affairs or a field that is relevant to the functions of Chapter Six of the Constitution.
- 37. The justification for the proposed amendments was that they were aimed at equipping the Regional Development Authorities with a professional Board which can spearhead the regional development policy, uphold governance and assist in resource mobilization of the Authority.

#### CLAUSE 12(4), 16(4), 20(4) AND 24(4)

- 38. The Ministry of East African Community and Regional Development proposed that the Managing Director should be appointed for a term of three years and re-appointment for one further term.
- 39. The Ministry, in its justification, stated that the proposal aligns with Mwongozo Guidelines on the term of office of a Managing Director which should be a term of three years and cumulatively not more than six years.

#### **SCHEDULE**

40. The Ministry of East African Community and Regional Development proposed that paragraph 2(4) of the Schedule should be amended by replacing the word "Council" with "Board" and to replace the word "number" with "member".

#### **NEW CLAUSE**

41. The Ministry of East African Community and Regional Development proposed that a new clause be inserted to provide for the functions of the Cabinet Secretary as follows.

#### The Cabinet Secretary shall—

- (a) be responsible for policy formulation and directions for purposes of this Act;
- (b) set national goals and objectives and determine policies and priorities for the sustainable development and use of natural resources in the basin area;

(c) be responsible for effective implementation of international agreements and relevant international laws in conformity with the Treaty Making and Ratification Act, 2013;

#### **NEW CLAUSE**

- 42. The Ministry of East African Community and Regional Development proposed insertion of a new clause on powers of Regional Development Authorities which will:
  - (a) grant the Authority the powers necessary for the execution of its functions;
  - (b) grant Authority powers to coordinate basin-based investments, projects and programmes;
  - (c) grant Authority powers to be able to do resource mobilization for development;
  - (d) grant Authority powers to be able to charge levies for services provided;
  - (e) grant Authority powers to work with other stakeholders.
- 43. The Ministry's justification was that the proposal was a generic clause on most State Corporations Act which is very important in empowering the State Corporation to undertake necessary activities.

#### **NEW CLAUSE**

- 44. The Ministry of East African Community and Regional Development proposed an inclusion of a clause on the Board Committees to allow for proper and efficient undertaking of the Board's functions.
- 45. The Ministry's justification was that establishing committees or subcommittees, the delegation of responsibilities to persons, members, employees are crucial to get the best professional advice, which is key to decision making. Further, the delegated authority must be exercised in the best interest of the organisation. But decisions emanating from such delegates should be subjected to the full Board for adoption, review and variation, where necessary.

#### **NEW CLAUSE**

- 46. The Ministry of East African Community and Regional Development proposed a new clause to prescribe provisions on termination of non-executive Board members to strengthen Board operations and ensure efficiency.
- 47. The Ministry's justification was that this will provide for exit or termination of non-executive members under necessary circumstances and provide for efficiency in the management of Boards.

#### **NEW CLAUSE**

- 48. The Ministry of East African Community and Regional Development proposed a new clause to provide for an exit or termination clause for the services of the Managing Director.
- 49. The Ministry's justification was that this will provide for exit or termination of Managing Director under necessary circumstances and provide for efficiency in the management of Boards.

#### **NEW CLAUSE**

- 50. The Ministry of East African Community and Regional Development proposed a new clause to provide for the establishment of a national basin-based database.
- 51. The Ministry's justification was that this will enhance the Regional Development Authorities functions in maintaining a comprehensive basin-based database.

#### **NEW CLAUSE**

- 52. The Ministry of East African Community and Regional Development proposed a new clause to provide for a monitoring mechanism to provide for the development of monitoring mechanisms and set indicators to determine—
  - (a) sound management of basin-based natural resources in Kenya; and
  - (b) trends affecting conservation and management of basin-based natural resources.

#### **PART IV**

#### 5.0 COMMITTEE RECOMMENDATION

53. The Committee having considered the Regional Development Authorities Bill, 2021 recommends that the House approves the Bill with amendments as proposed in the schedule.

#### 6.0 SCHEDULE OF PROPOSED AMENDMENTS

54. The Committee proposes the following amendments to be considered by the House in the Committee stage:

#### TITLE

**THAT**, the Title to the Bill be amended by deleting the word "REGIONAL" and substituting therefor the word "BASIN-BASED"

#### **Justification**

The Authorities are based on respective water basins.

The word Regional is arbitrary since it is not confined to any specific geographical meaning. It can be construed to mean Central region, eastern region, western region, east African region, African region.

#### LONG TITLE

**THAT**, the Long Title to the Bill be amended by deleting the words "regional development bodies" appearing immediately after the words "functions of" and substituting therefor the words "basin-based development bodies".

#### Justification

The Authorities are based on respective water basins.

The word Regional is arbitrary since it is not confined to any specific geographical meaning. It can be construed to mean Central region, eastern region, western region, east African region, African region.

#### **CLAUSE 1**

**THAT,** Clause 1 of the Bill be amended by deleting the word "Regional" and substituting therefore the word "Basin-Based".

#### **Justification**

The Authorities are based on respective water basins.

The word Regional is arbitrary since it is not confined to any specific geographical meaning. It can be construed to mean Central region, eastern region, western region, east African region, African region.

#### **CLAUSE 2**

**THAT**, Clause 2 of the Bill be amended—

- (a) in the definition of 'Cabinet Secretary" by deleting the word "regional" appearing immediately after the words "relating to" and substituting therefor the word "basin-based";
- (b) in the definition of "Chairperson" by deleting the word "regional" appearing immediately after the words "appointed as a" and substituting therefor the word "basin-based";
- (c) in the definition of "Lake Basin by deleting the words "that part of Lake Kyoga catchment area situated within Kenya" and substituting therefor the words "drained area bounded by watersheds of the river Nzoia, Yala, Nyando, Sondu, and Kuja and their tributaries which drain into Lake Victoria".

#### Justification

The Authorities are based on respective water basins.

The word Regional is arbitrary since it is not confined to any specific geographical meaning. It can be construed to mean Central region, eastern region, western region, east African region, African region.

#### **CLAUSE 4**

**THAT**, Clause 4 of the Bill be amended—

- (a) in sub clause (1) by deleting the word "regional" appearing immediately after the words "publish a" and substituting therefor the word "basin-based";
- (b) in sub clause (2) by deleting the word "regional" appearing immediately after the word "The" and substituting therefor the word "basin-based".

#### **Justification**

The Authorities are based on respective water basins.

The word Regional is arbitrary since it is not confined to any specific geographical meaning. It can be construed to mean Central region, eastern region, western region, east African region, African region.

#### PART II—HEADING

**THAT**, the Bill be amended in the Heading to Part II by deleting the word "REGIONAL" and substituting therefor the word "BASIN-BASED".

#### Justification

The authorities are Basin -based, have similar functions and governance structure; collapsing then avoids repetition.

The proposed amendment makes the Act/Bill lean and also gives room for provision for establishment of additional Authorities

#### **CLAUSE 5**

**THAT**, the Bill be amended by deleting Clause 5 and substituting therefore with the following new Clause—

Establishment and incorporation of basin-based development authorities.

- **5.** (1) There is established basin-based development authorities to be known as—
- (a) the Coast Development Authority, with respect to the Coast region;
- (b) the Ewaso Ng'iro North River Basin Development Authority, with respect to the Ewaso Ng'iro North River Basin;
- (c) the Ewaso Ng'iro South River Basin Development Authority, with respect to the Ewaso Ng'iro South River Basin;
- (d) the Kerio Valley Development Authority, with respect to the Kerio River basin;
- (e) the Lake Basin Development Authority, with respect to the Lake Victoria Basin; and
- (f) the Tana and Athi Rivers Development Authority, with respect to the Tana and Athi Rivers basins.
- (2) Subject to subsection (3), the President may on the recommendation of the Cabinet Secretary, establish one or more basin-based development authorities and define the geographical area of jurisdiction of each such authority.
- (3) The Cabinet Secretary shall, in consultation with relevant stakeholders, develop criteria for the establishment of basin-based development authorities.

- (4) Each basin-based development authority established under this section shall be a body corporate with perpetual succession and a common seal and shall, in its corporate name, be capable of—
  - (a) suing and being sued;
  - (b) taking, purchasing or otherwise acquiring, holding, charging and disposing of movable and immovable property;
  - (c) borrowing and lending money;
  - (d) entering into contracts; and
  - (e) doing or performing all such other things or acts necessary for the proper performance of its functions under this Act which may lawfully be done or performed by a body corporate.

#### Justification

The authorities are Basin -based, have similar functions and governance structure; collapsing then avoids repetition.

The proposed amendment makes the Act/Bill lean and also gives room for provision for establishment of additional Authorities

#### **CLAUSE 6**

**THAT**, the Bill be amended by deleting Clause 6 and substituting therefor the following new clause—

Management of basinbased development authority established under this Act shall be managed by a Board comprising—

- (a) a chairperson appointed by the President;
- (b) the Principal Secretary of the Ministry for the time being responsible for basin-based development or an officer of that Ministry designated by the Principal Secretary in writing;

- (c) the Principal Secretary of the Ministry for the time being responsible for finance or an officer of that Ministry designated by the Principal Secretary-in writing;
- (d) the Principal Secretary of the Ministry for the time being responsible for environment or an officer of that Ministry designated by the Principal Secretary in writing;
- (e) five other members appointed by the Cabinet Secretary as provided in sub-section (2); and
- (f) the Managing Director who shall be the chief executive officer and an *ex-officio* member of the Board
- (2) In appointing the Chairperson and members to the Board, the President and the Cabinet Secretary shall observe the principle of gender equity and regional balance.
- (3) A person shall be qualified for appointment under subsection (1)(e) if the person—
  - (a) holds a diploma certificate from an institution recognized in Kenya;
  - (b) has experience in public affairs, resource mobilization, governance or a field relevant to the functions of a basin-based development authority; and
  - (b) meets the requirements of Chapter Six of the Constitution.
- (4) The chairperson and members of the Board appointed under subsection (1) (a)&(e) shall hold office for a period of three years from the date of appointment, and shall be eligible for reappointment for one further term of three years.

#### Justification

The authorities are Basin -based, have similar functions and governance structure; collapsing then avoids repetition.

The proposed amendment makes the Act/Bill lean and also gives room for provision for establishment of additional Authorities

#### **CLAUSE 7**

**THAT**, the Bill be amended by deleting Clause 7 and substituting therefor the following new Clause—

Functions of basin-based development authorities.

- 7. Each basin-based development authority established under this Act shall, with respect its area of jurisdiction
  - (a) advise the Government and other institutions on all matters pertaining to national policy on basin based natural resources, sustainable management and utilization, integrated socio-economic development programme and projects, and investment opportunities;
  - (b) initiate, plan, co-ordinate and implement, national policies, projects and programmes related to integrated development and sustainable utilization of basin based natural resources;
  - (c) initiate, undertake and co-ordinate national studies on conservation and sustainable utilization of basin based natural resources;

  - (g) mobilize resources and undertake national investments for sustainable utilization of basin-based resources and selfsustainability;

- (h) co-ordinate the design and implementation of the country's regional and international commitments pertaining to conservation and sustainable utilization of Basin Based natural resources:
- (i) undertake national programmes and projects on climate change adaptation and mitigation to enhance National capacity and resilience through technology transfer and other means;
- (j) plan and liaise with the relevant authorities as necessary in national exploration, utilization and development of extensive fishing and aqua cultural activities in Lake Victoria and its basin and marine activities in Kenya including in the exclusive economic zone.
- (k) implement relevant national government strategic programmes and perform other related functions and activities as may be necessary to promote and sustain socioeconomic development;
- (l) approve all natural resources-based projects and programs to be implemented in the Basins; and
- (m)perform any other function which the Cabinet Secretary may assign the Basin Based Development Authority or is incidental or conducive to the exercise by the Basin Based Development Authority of any or all of the functions provided under this Act.

- (k) implement relevant national government strategic programmes and perform other related functions and activities as may be necessary to promote and sustain socioeconomic development;
- (l) approve all natural resources-based projects and programs to be implemented in the Basins; and

(m)perform any other function which the Cabinet Secretary may assign the Basin Based Development Authority or is incidental or conducive to the exercise by the Basin Based Development Authority of any or all of the functions provided under this Act.

### Justification

- iii) Clause 6, 10, 14 & 18 on composition of the Boards for the RDAs The Ministry proposal aligns with Mwongozo guideline on the composition numbers which should be between 7-9 members. *Justification:* The Committee Bill has proposed an 11 member Board which exceeds Mwongozo guidelines;
- iv) Clause 6 (3), 10 (3), 14 (3) & 17 (3) The Ministry has proposed to prescribe extensive qualifications for both the Chairperson and the non-government Board members; *Justification:* This is aimed at equipping the RDAs with a professional Board which can spearhead the regional development policy, uphold governance and assist in resource mobilization.
- v) Clause 12 (4), 16 (4), 20 (4) & 24 (4) The Ministry proposes the Managing Director to be appointed for a term of 3 years and re-appointment for one further term. *Justification:* The Ministry proposal aligns with Mwongozo guidelines on the term of office of a Managing Director which should be a term of 3 years and cumulatively not more than 6 years;
- vi) Add termination clause for non-executive members of the Board The Ministry has proposed to prescribe provisions on termination of non-executive Board members to strengthen Board operations and ensure efficiency; *Justification:* This will provide for exit/termination of non-executive members under necessary circumstances and provide for efficiency in the management of Boards;
- vii) Add termination clause for the Managing Director The Ministry proposed inclusion of an exit/termination clause for the services of the Managing Director. *Justification:*

This will provide for exit/termination of Managing Director under necessary circumstances and provide for efficiency in the management of Boards;

- viii) Establishment of National Basin Based database The Ministry has proposed to include a Clause on the establishment of a National Basin Based Database. *Justification:* This will enhance the Regional Development Authorities functions in maintaining a comprehensive basin based database;
- ix) Monitoring mechanisms The Ministry proposed to include a Clause on Monitoring Mechanism to provide for the development of monitoring mechanisms and set indicators. *Justification:* This will enhance the monitoring function of the Regional Development Authorities on basin based natural resources.

### Way forward

# BRIEF ON KVDA'S PROJECTS IN TURKANA COUNTY BY KERIO VALLEY DEVELOPMENT AUTHORITY

The CEO, Mr. Sammy Naporos apprised the committee on projects being implemented by Kerio Valley Development Authority (KVDA) in Turkana County as follows:-

- i) The 150 acres Loyapat scheme located in Turkana south, the scheme was handed over to the local community and currently benefiting 150 households;
- ii) KVDA developed and installed Napuu irrigation scheme, a solar powered 2 centre pivot irrigation system on 150 acres in Turkana central. The farm is currently being used for food production;
- iii) The Authority developed three (3) small dams in Turkana west namely Nakule Akiring, Matakul and Namadi;
- iv) The dams are currently producing water that is benefiting over 3,000 people and over 5,000 livestock:
- v) Development of forty one (41) water pans distributed in the entire county to provide water for human and livestock consumption;
- vi) Fifteen (15) boreholes rehabilitated and handed over to the local communities;
- vii) Five (5) boreholes drilled and equipped in Napuu, the boreholes are used to produce water for human and livestock consumption and for irrigation purposes;
- viii) The Authority procured speed boat which is currently being used for rescue operations at Kalokol, Lake Turkana
- ix) Further, the Authority is planning to undertake the utilization of water from Turkwel dam to irrigate to irrigate 30,000 ha under food production in lower Turkwel;
- x) Development of Kalokol fish processing plant in Turkana Central to support fish production by local fish farmers;
- xi) Development of Todonyang irrigation scheme, Turkana North;
- xii) Drilling and equipping of four (4) solar powered boreholes to benefit over hive hundred (500) households in Turkana North, Turkana East, and Turkana west

BRIEFING BY PARLIAMENTARY BUDGET OFFICE (PBO) ON THE ADDENDUM TO THE REPORT ON SUPPLEMENTARY ESTIMATES (1) FOR FY, 2021/22

Mr. Edwin Machuki, fiscal analyst from The Parliamentary Budget Office briefed the Committee as follows':

i) The National Treasury received requests for additional funding from MDA's after the submission of FY 2021/22 Supplementary Estimates (I);

ii) Being an election year and with only four months remaining to end of the FY, it may not be feasible for the National Treasury to prepare Supplementary II thus necessitating amendments for additional funding;

iii) The amendments are only for the Ministry of Defence (MoD) and National Intelligence Service (NIS) that constitute the National Security Sector;

iv) In the amendment, the MoD proposed additional funding is Kshs. 100.00 million for election preparedness while for NIS is Kshs. 1,250.00 million to cater for security operations for election preparedness;

v) The proposed addition for MoD is towards the Defence programme while for NIS is for the National Security Intelligence programme.

vi) The amendments do not have an impact on the committee earlier recommendations to the Budget and Appropriations Committee (BAC) but have resulted to increase of additional resources for MoD from Kshs. 15,126.26 million to Kshs. 15,226.26 million while for NIS from Kshs. 2,200.00 million to Kshs. 3,450.00 million.

### **Committee Recommendations**

The Committee noted the purpose of the enhanced allocation as indicated in the National Treasury Addendum as Security operations and for election preparedness and therefore recommended as follows:-

i) Additional Allocation of Kshs. 100 Million to the Ministry of Defence

ii) Additional Allocation of Kshs. 1,250 Million to the National Intelligence Service

iv) These are Coast Development Authority, Ewaso Ng'iro North River Basin Development Authority, Ewaso Ng'iro South River Basin Development Authority, Kerio Valley Development Authority, Lake Basin Development Authority, Tana and Athi Rivers Development Authority;

v) The Bill standardizes the functions of regional development authorities subject to the

unique areas of operation of each regional development authority;

vi) It further standardizes the membership of the Boards of each regional development authority to eleven (11) members in line with best practices in corporate governance;

vii) In regards to public participation the Committee is required, pursuant to Standing Order 127(3), to facilitate public participation on the Bill through an appropriate mechanism;

### **Committee Resolution**

The Committee resolved to retreat during the upcoming short recess to examine the bill clause by clause. Further, the secretariat was tasked to process newspaper advertisements for call for public participation.

The Committee tasked the secretariat to write to the Inspector General of Police reminding him of the three-month deadline that the Committee had accorded him on the matter of the murder of Ms. Agnes Wanjiru in Nanyuki. Further, the Committee resolved to visit the British Army Training Unit, as well as engage with local leadership, in its consideration of the Defence Cooperation Agreement, on 14<sup>th</sup> January 2022, subject to availability of funds.

# MIN. NO.NA/DDC.DFR/2022/004: BRIEFING BY THE PARLIAMENTARY BUDGET OFFICE ON THE BUDGET POLICY STATEMENT 2022

The fiscal analysts briefed the Committee on the Budget Policy Statement (BPS) for financial year 2022/2022 and the medium term. The following were the key highlights;

- 1. The 2022 BPS was themed 'Accelerating Economic Recovery for Improved Livelihood', against a backdrop of anticipated economic recovery, expected to hit 5.8% after a period of economic decline occasioned by the covid pandemic. The calendar of the budget cycle had been adjusted due to the forthcoming General Election;
- 2. The country's total expenditure basket will increase to Kshs. 3,309.14 billion, with the security sector (defence and national intelligence) being 9.8% of the whole. The sector is facing challenges of terror and other security related risks as the country approaches the General Election;
- 3. The Ministry of Defence has a proposed ceiling of Kshs. 157.57 billion, an improvement from the outgoing financial year's allocation of Kshs. 119.57. This is attributable to the modernization of equipment, done under the Export Credit Arrangement (ECA). Details of these projects have however not been provided. Noteworthy is that the civil aid component has been reduced by Kshs. 300 million;
- 4. The National Intelligence Service has a proposed ceiling of Kshs. 45.53 billion, compared to the previous year's Kshs. 42.45 billion. Details of its programmes have also not been availed;
- 5. The Ministry of Foreign Affairs has a proposed ceiling of Kshs. 19.55 billion, a slight increase from Kshs. 18.82 billion for FY 2020/21 representing a 4% growth. This is however against a sector requirement of Kshs. 47.37 billion, a 59% shortfall that will negatively impact programmes, especially the development component that has a Kshs. 9.26 billion deficit (84%);
- 6. The State Department for East African Community has a proposed ceiling of Kshs. 0.65 billion, all recurrent, compared to Kshs. 0.61 billion in the outgoing financial year;
- 7. The State Department for Regional and Northern Corridor Development has a proposed ceiling of Kshs. 4.22 billion, of which Kshs. 0.97 billion is for development.

This is against a development resource requirement of Kshs. 23.16 billion, representing a 96% shortfall. This indicates that projects earmarked under the state department will not be achieved;

8. Other than the budgetary constraints already alluded to above, other key issues include increased debt burden that will be incurred by the Ministry of Defence's ECA projects to the tune of Kshs. 27 billion. The BPS did also not provide a list of pending bills that have always been a thorn in the flesh, invariably eating into ministry allocations as first charge. Moreover, several court awards have not been factored in and there lacks a policy on how they should be offset.

The Committee noted that they Ministries and Agencies under its purview have been scheduled to appear before it on Wednesday 2<sup>nd</sup> February 2022 to justify their ceilings, and respond to all emergent issues in the BPS as noted above, most importantly itemized lists of all their projects.

The Committee noted that further to objections by the State Department of Regional and Northern Corridor Development, and the Attorney General, to the legislative proposal, Treasury had also written to oppose the same.

The Committee resolved to draw parallels between its proposed Regional Development Authorities Bill 2021 that seeks to amalgamate all such Acts of Parliament, and the proposal by Hon. Christopher Nakuleu, in order to accommodate concerns of the Member.
