Pursuant to Article 155(3) of the Constitution, H.E. the President, forwarded to the Clerk of the National Assembly, the nominations of Dr. Andrew Kiprotich Tuimur and Mr. Patrick Mwangi Nduati vide a letter dated 2nd December, 2015 for vetting by the Departmental Committee on Agriculture, Livestock and Cooperatives and consideration for approval by the National Assembly for appointment as Principal Secretary, State Department of Livestock, Ministry of Agriculture, Livestock and Fisheries and Principal Secretary for State Department of Irrigation, Ministry of Water and Irrigation respectively.

On Wednesday 2nd December, 2015 the Honourable Speaker in a Communication from the Chair pursuant to Standing Order 42(1), informed the House that the he had received the notification of nomination of Dr. Andrew Kiprotich Tuimur and Mr. Patrick Mwangi Nduati and referred the same to the Departmental Committee on Agriculture, Livestock and Cooperatives for vetting and reporting to the House within fourteen (14) days (by 17th December, 2015).

2.0 Adoption

3.0 BACKGROUND

3.1 Establishment of the Committee

The Departmental Committee on Agriculture, Livestock and Co-operatives is established pursuant to provisions of Standing Order 216 (5) is mandated to vet all appointments where the Constitution or any law requires the National Assembly to approve, except those under Standing Order 204 (Committee on Appointments); and report to the House pursuant to Article 155(3) of the Constitution. The said Article requires H.E. the President to nominate and with the approval of the National Assembly, appoint Principal Secretaries. Section 7(10) of the Public Appointments (Parliamentary Approval) Act 2011, *provides that, where the nomination of a candidate is rejected by Parliament, the appointing authority may submit to the relevant House the name of another candidate, and the procedure for approval specified in this Act shall apply accordingly.*

3.2 Appointment process of the Principal Secretary nominee

(i) In accordance with the provisions of Article 155(3) of the Constitution, H.E. the President forwarded to the Speaker of the National Assembly, the nomination of Dr. Andrew Kiprotich Tuimur and Mr. Patrick Mwangi Nduati vide a letter dated 1st December, 2014 for vetting by the Departmental Committee on Agriculture, Livestock and Co-operatives and consideration for approval by the National Assembly for appointment as Principal Secretary for State Department of Livestock , Ministry of Agriculture, Livestock and Cooperatives and Principal Secretary, State Department of Irrigation, Ministry of Water and Irrigation respectively

(ii) On Wednesday 2nd December, 2015 the Honourable Speaker in a Communication from the Chair pursuant to Standing Order 42(1),

On 3rd December, 2015, the Clerk of the National Assembly wrote to the Ethics and Anti-Corruption Commission, Kenya Revenue Authority (KRA), Higher Education Loans Board (HELB) and Credit Reference Bureau (CBR) requesting for reports about the nominee on: -

- Matters touching on integrity;
- Tax compliance;
- Loan repayments.

In response, HELB confirmed vide a letter Ref. HELB/RD/56593/POV/182 dated 8th December, 2015 that the nominees cleared his HELB Loans obligation in February, 2013. Kenya Revenue Authority confirmed vide a letter Re. CDT/HQ/54 dated 8th December, 2015 that the nominees was tax compliant. The Ethics and Anti-Corruption Commission vide a letter Ref. EACC.7/10/5Vol.II (3) dated 7th December, 2015 confirmed that there was no outstanding issues and ongoing investigation against the nominees.

3.5 Submission of memoranda

Section 7 of the Public Appointments (Parliamentary Approval) Act, 2011 provides that the issues for consideration by the relevant House in relation to any nomination shall be:-

- (a) the procedure used to arrive at the nominee;
- (b) any constructional or statutory requirements relating to the office in question; and
- (c) the suitability of the nominees for appointment proposed having regard to whether the nominee's abilities, experience and qualities meet the needs of the body to which nomination is being made.

Pursuant to Section 6(9) of the said Act, the Committee invited submissions from the public on the suitability or otherwise of the nominee for appointment to the positions of Principal Secretary. The Committee did not receive any submission on the Nominees:-

1. Educational and Professional Qualifications

He took Members through his educational and professional background and stated that: -

- (i) He pursued Masters of Science degree from University of Edinburg (UK) and a Bachelors of Veterinary Medicine from the University of Nairobi.
- (ii) He was employed in the University of Nairobi as an Assistant Lecturer in the Faculty of Veterinary Medicine in 1985 and taught for one year.
- (iii) He joined the Agricultural Development Corporation (ADC) in 1986 as Veterinary Officer in Nakuru Division and rose to the rank of Managing Director in 2014.
- (iv) He is currently the Managing Director of Agricultural Development Corporation (ADC)
- (v) He has served as a Board Member in the following institutions
 - a) National Standards Council (2002-2003)
 - b) Insurance Advisory Board as Chairman (1999-2002)
 - c) Agro-Chemical and Food Company Limited as Chairman (2014-date)
 - d) Chemilil Sugar Company Ltd as Chairman (2014-date)

- (ii) During his tenure in Agricultural Development Corporation, he facilitated the launch of two seed varieties of grass and fodder crop vital in the ensuring that farmers get quality fodder that can adapt to the various parts of the country.
- (iii) He stated that, among the mandates of the Agricultural Development Corporation (ADC) is to develop and multiply potato seeds. During his tenure, he participated in the revival of potato industry by providing certified and high yielding seeds to the farmers.
- (iv) He participated in the establishment of the second bull station in Kenya that is in Trans-Nzoia County. This new Bull station shall be a model station and is expected to drastically bring down the cost of semen in the country.

4. Success of the Livestock Production programs in Agricultural Development Corporation

- (i) He said that in 1990s most of the best farms including the Naivasha farm belonging to the Agricultural Development Corporation were allocated to the individuals. Due to this change of ownership of these former ADC farms, expansion of the livestock industry in ADC has been significantly curtailed. He stated that, during his tenure, he has ensured that all the ADC farms have been gazetted and process of fencing the farms is ongoing.
- (ii) He informed the Committee that, In the recent past the country has witnessed dwindling numbers of the livestock mostly due to drought and animal diseases; As a result, while at ADC he has being

- (ii) The former Cabinet Secretary of Agriculture ,Livestock and Fisheries chaired a number of intergovernmental meetings involving ADC, NIB, Ministry of Water, Environment and Natural Resources in attempt to indentify between ADC and NIB would spearhead the project. It was decided that NIB would spearhead the implementation project. The NIB would lease the land and pay lease to ADC. It was during this process that ADC almost signed a MoU that was to be forwarded to Attorney General for review and approval but it was later on cancelled.
- (iii) He stated that ADC did not sign any contract with Green Arava but it was NIB that signed a commercial contract with Green Arava.

7. Measures he would put in place to enhance efficiency and access to public service in the State department of Livestock

- (i) He stated that, having interacted with State department of Livestock he has noted that there is lack of synergy between the veterinary and livestock production departments in State department. This lack of coordinated approach in the implementation of programs has led to duplication and wastage of resources in implementation of livestock sector programs. He informed the Committee that, his first priority if approved for appointment, is to restructure the two departments to ensure there is targeted approach to programs and synergy is realized.
- (ii) He informed the Committee that, he will liaise with County Government to ensure extension services and veterinary officers are easily accessed since these functions have since been devolved.

10. Policies and Strategies that the nominee would put in place to increase livestock Production

- (i) He said he will work with county governments to build capacity of the various sector actors especially the farmers and local investors to concentrate on value addition. The key among the targets is to recapture the EU beef products quota by among other activities investing in Disease Free zones for livestock among other activities.
- (ii) He undertook to focus on priority programs like management of animals during drought which will include strengthening insurance cover.
- (iii) In regard to dairy he stated that he ensure that improvement of dairy processing in terms of value addition is realized and set up model farms and focus on embryo transfers for breeding heifers

11. Hindrance for expansion and effectiveness of the irrigation programs and how the nominee plans to overcome them

- (i) He said livestock department is grossly underfunded and he will work towards lobbying for additional funds noting that in the current financial years State department had been allocated approximately Kshs 7 billion for which Kshs 2 billion is donor money.
- (ii) He stated that some of the Livestock policies need to be changed given the current trends in livestock production and stressed the need to increased the participation of private sector in the industry to

- d) Acting Managing Director in 2010

- (vi) Attended managerial courses and seminars throughout his career including the following:-
 - Strategic Planning Workshop (2009)
 - Corporate Governance Course (2002)and (2008)
 - Corruption Prevention (integrity Course)
- (vii) Currently a Member of Veterinary Association and Veterinary Board of Kenya.
- (viii) Although he did not declare while filling the Parliamentary Approval questionnaire. The Nominee while introducing himself to the Committee acknowledged that he contested for a Parliamentary Seat in 2002 but was unsuccessful. However he confirmed to the Committee that he has no plans to run for a Political contest.

The Committee further observed that the nominee:-

- (i) Has satisfied the requirements of Chapter 6 of the Constitution of Kenya on leadership and integrity.
- (ii) Has been cleared by the Directorate of Criminal Investigation (DCI), Kenya Revenue Authority on tax compliance, Higher Education Loans Board (HELB) and the Credit Reference Bureau.
- (iii) Has never been charged in a Court of Law and has no potential conflict of interest,
- (iv) Has never been dismissed from office for contravention of the provisions of Article 75 of the Constitution which deals with conduct

interviewed by the Committee and responded to questions during the vetting as follows:-

1. Educational and Professional Qualifications

He took Members through his educational and professional background and stated that: -

- (i) He pursued Bachelor's Science Civil Engineering from the University of Nairobi and a Master's of Science Environmental Engineering from the University of Durban-Westville, South Africa. Further he is holds a Certificate of Finance and Finance Law from the University of London.
- (ii) He is currently a Senior Specialist in Water and Sanitation in the World Bank having previously worked as a Country representative (Africare) in Sierra Leone between April 2004 and February 2006 and Coordinator of International Rescue Committee in Sierra Leone in 2003-2004.
- (iii) He formerly served as Program Director in JIBM (Regional Knowledge Management Organization) Uganda in 2003, Deputy Director IRC in Burundi and East Timor in 2000 -2003, Water and Sanitation Coordinator IRC in Burundi in 1997-2000 and Water and Sanitation Operation Engineer Ministry of Local Government in 1992-1995.

2. Work experience in relations to the mandate of a Principal Secretary in State Department of Irrigation

He stated that

3. **Nominee's work experience which has largely been outside the country in relation to local operational dynamics as a Principal Secretary, State Department of Irrigation**

- (i) He stated that it was not true that his entire work experience has been outside the country as a matter of fact he noted that he has only worked abroad for 8 years against his over 25 years working experience. While in Kenya he had worked in senior management level both at the World Bank group and the Local Government.
- (ii) Asked how he will mitigate against flooding, he responded that he has worked in Water and Sanitation where drainage is also involved. He has participated in construction of dykes to control flooding in Nzoia and Budalangi areas.

4. **Nominee's current remuneration against the remuneration of a Principal Secretary**

- (i) He indicated that his current remuneration in the World Bank group is likely to be higher than that of a Principal Secretary. However, he pointed out that, serving at this highest level and serving his country was enough motivating factor for him given that he will equally be influencing policy.
- (ii) He indicated that in the event that his nomination is approved, he may seek for negotiation of his terms if it will be possible.

5. **The Nominee's net worth and source of his wealth**

He stated that;

- (i) He owns a 55 acres of land in Naivasha which he started purchasing in 2007. He pointed out that the estimated current value of the land as

- (ii) Is a graduate of Civil Engineering from the University of Nairobi and holds a Masters in Science in Environmental Engineering from the University of Durban- Westville in South Africa.
- (iii) Has wealth of professional experience in the Water and Sanitation arising from the fact that he has worked in many international institutions as coordinator and Water and Sanitation specialist. However the Committee noted that the nominee had limited experience on matters irrigation.
- (iv) Is currently a Senior Specialist in Water and Sanitation in the World Bank. Previously he has worked as a Country representative (Africare) in Sierra Leone between April 2004 and February 2006, Coordinator of International Rescue Committee in Sierra Leone in 2003-2004.
- (v) Formerly served as Program Director in JIBM (Regional Knowledge Management Organization) Uganda in 2003, Deputy Director IRC in Burundi and East Timor in 2000 -2003, Water and Sanitation Coordinator IRC in Burundi in 1997-2000 and Water and Sanitation Operation Engineer Ministry of Local Government in 1992-1995.
- (vi) Did not produce the original degree certificate of his first degree at the time of vetting. However upon the request of the Committee, the nominee submitted a certified copy of the degree certificate certified by the University of Nairobi on 15th December 2015.

The Committee further observed that the nominee:-

- (i) Has satisfied the requirements of Chapter 6 of the Constitution of Kenya on leadership and integrity.
