ENTITLED

**THE EAST AFRICAN COMMUNITY  
SUPPLEMENTARY APPROPRIATION ACT, 2023**

**An Act of the Community to appropriate a sum of United States Dollars sixteen million, four hundred and eight thousand, forty-five out of the budget of the Community to meet additional expenditure for the Organs and Institutions of the Community for the financial year ending 30<sup>th</sup> June, 2023.**

ENACTED by the East African Community and assented to by the Heads of State.

1. This Act may be cited as the East African Community Supplementary Appropriation Act, 2023 and shall be deemed to have come into force on the 1<sup>st</sup> day of July, 2022. Short title and Commencement.
2. The sum of United States Dollars sixteen million, four hundred and eight thousand, forty-five is allowed out of the budget of the Community to meet additional expenditure for the Organs and Institutions of the Community, as specified in the Schedule, for the financial year ending 30<sup>th</sup> June, 2023. Supplementary appropriation for financial year ending 30<sup>th</sup> June, 2023.
