PREFACE

Mr. Speaker, Sir,

On behalf of Members of the Departmental Committee on Defence and Foreign Relations, I feel greatly honoured to present to the House the Report containing the Recommendations and Minutes of the Committee on the Draft Treaty for the Establishment of the East African Community.

Mr. Speaker, Sir,

Allow me to begin by sincerely thanking these Members of the Committee for their co-operation and dedication in pursuing the objectives for which the Committee was established and specifically in deliberating on the Draft Treaty. I feel indebted to their invaluable contribution and commitment in producing this report.

Mr. Speaker, Sir,

The terms of reference for this Committee are set out in Standing Order 151 (4) which states as follows:-

- (a) to investigate, inquire into, and report on all matters relating to the mandate, management, activities, administration, operations and estimates of the assigned Ministries and departments;
- (b) to study the programme and policy objectives of the Ministries and departments and the effectiveness for the implementation;
- (c) to study and review all legislation after First Reading, subject to the exemptions under Standing Order 101 A (4);
- (d) to study, assess and analyze the relative success of the Ministries and departments as measured by the results obtained as compared with its stated objectives;
- (e) to investigate and inquire into all matters relating to the assigned Ministries and departments as they may deem necessary, and as may be referred to them by the House or a Minister; and
- (f) to make reports and recommendations to the House as often as possible including recommendation of proposed legislation.

The mandate of this Departmental Committee, therefore, covered the following Ministries;-

- (i) The Office of the President and specifically the department incharge of national defence.
- (ii) The Ministry of Foreign Affairs
- (iii) The Ministry of East African and Regional Co-operation

Mr. Speaker, Sir,

When the Committee met for the first time on 23rd July, 1998, it generally became apparent that although there were many issues under its purview which were yearning for attention, the consideration of the Draft Treaty for the Establishment of the East African Community, which had just been laid in this House, was of utmost priority.

Consequently, the Committee held a total of thirty-one sittings during which time the members went through the Draft Treaty Article by Article at considerable detail, in the process eliciting heated, albeit interesting discussions, the result of which are the proposals I am presenting to the House today.

Mr. Speaker, Sir,

Allow me to take this early opportunity to recognize the significance of the reports of the forums convened to discuss the Draft Treaty, namely:

- (i) The East African Co-operation meeting of Speakers of the National Assemblies held at Arusha, Tanzania between 4th 5th June, 1998.
- (ii) The Workshop at Kenya School of Monetary Studies at Ruaraka, Nairobi between 24 25th September, 1998 which was organized by the Ministry of East African and Regional Co-operation.
- (iii) The East African Co-operation meeting of Speakers of the National Assemblies held at Arusha, Tanzania between 18th 19th May, 1999.

The input of these meetings in the treaty making process cannot be ignored and the Committee found their proposals useful. Infact, Chapter Twenty Four on Standardisation, Metrology, Quality Assurance, Quality Management and Accreditation has been completely re-written as recommended by experts drawn from the three Bureaux of Standards of Kenya, Uganda and Tanzania during their sectoral meeting in May, 1998.

The Committee invited and exchanged views on the Treaty with officials from various Ministries. In this respect, I would like to thank Hon. K.N.K. Biwott, E.G.H., M.P. - Minister for East African and Regional Co-operation and Hon. J.J. Kamotho, E.G.H., M.P. - Minister for Trade, for their valuable contribution.

Last but not least, may I also express my gratitude to the Secretariat from the Clerk's Chambers who played a crucial role in organizing the Committee meetings by securing the venue and facilities required, taking the Minutes and the recommendations which culminated into the production of this report.

PROPOSED AMENDMENTS TO THE DRAFT TREATY

PREAMBLE

The Committee recommends that the Preamble should also include the principles that necessitate the establishment of the proposed Community.

The Committee further recommends that the last paragraph in the Preamble be amended to read;

"DETERMINED to strengthen their Economic, Social, Cultural, Political and other ties for their fast balanced and sustainable development by the establishment of an East African Community, with a Common Market as an integral part, subsequently a Monetary Union and ultimately a Political Federation founded on the development of comparable and compatible political institutions and observance of the principle of pluralism thereof:"

CHAPTER TWO ESTABLISHMENT AND PRINCIPLES OF THE COMMUNITY

Article 2 - Establishment and Membership of the Community

The Committee recommends that no state should be admitted into the Community under paragraph 5 until the Council provided for in paragraph 8 is legally constituted and the protocol detailing procedures for admission have been agreed upon.

Article 4 - Objectives of the Community

The Committee recommends that the Article be amended as follows:-

- (i) Under 4(1), the words "research and technology" be inserted immediately after the word "economic" on the third line.
- (ii) Under 4(3), a new sub-paragraph (h) be inserted to read; "The promotion of a common education curriculum, research and human resource development".

CHAPTER FOUR THE SUMMIT

Article 9 - Composition of the Summit

The Committee recommends that the Summit should consist of the Heads of State and Government.

Article 10 - Functions of the Summit

The Committee recommends that 10(8) be amended to read;

"Any Member of the Summit may record his objection to a proposal submitted for the decision of the Summit and if any such objection is recorded, the Summit shall proceed with the proposal provided that the majority vote is obtained and provided that such proposal does not involve the admission of a new member, or the proposal does not have a direct bearing on the dissenting Member, then for which a unanimous decision will be mandatory".

CHAPTER FIVE THE COUNCIL

Article 12 - Functions of the Council

The Committee recommends that the Article be amended as follows:-

- (i) Under 12(2), a new sub-paragraph (m) be inserted to read;
 - "shall prescribe procedures for the accreditation of observer status for intergovernmental organisations and foreign countries".
- (ii) The numbering from 4 11 to change and read as from 3 10.

CHAPTER SIX THE CO-ORDINATION COMMITTEE

Article 15 - Functions of the Co-ordination Committee

The Committee recommends that a clear separation of roles be established between the Co-ordination Committee and the Secretariat particularly the harmonisation of Article 15 (1)(d) with Article 64(1)(k) which appears to be in conflict.

CHAPTER SEVEN THE EAST AFRICAN COMMUNITY COURT

Article 18 - Role of the East African Community Court

The Committee recommends that the Partner States should work towards the reestablishment of the East African Court of Appeal separate from the East African Community Court.

Article 20 - Tenure of Office of Judges

The Committee recommends that the judges should serve a single term of seven years.

CHAPTER EIGHT THE EAST AFRICAN COMMUNITY ASSEMBLY

The Committee recommends that the Assembly be called the "East African Legislative Assembly" instead of the "East African Community Assembly".

Accordingly, the name should be changed in Chapters Three, Eight and wherever it appears in the Draft Treaty.

Article 44 - Composition of the East African Legislative Assembly

The Committee recommends that the Article be amended as follows:-

- (i) Under 44 (1)(a), the membership of the Assembly be revised from twenty seven elected members to forty five.
- (ii) Under 44(4), the words "on the recommendation of the Assembly" be inserted immediately after the word "shall " in the first line.

Article 45 - Functions of the Assembly

The Committee recommends that paragraphs 1 and 2 be deleted and the following three paragraphs be inserted in place thereof:-

- 1. "Subject to the provisions of this Treaty, the Community may through its Assembly, enact measures to which legislative effect may be given in the Partner States with respect to such matters as the Summit may from time to time, determine.
- 2. The Assembly may discuss any matter pertaining to the Community.
- 3. The Assembly shall liaise with the legislatures of the Partner States on

Consequently, Article 57 should be deleted.

Article 46 - Election of members of the Assembly

The Committee recommends that the Article be amended as follows:-

(i) Paragraph 1 be rephrased to read;

"The National Assembly of each Partner State shall elect fifteen members for the Assembly, who shall represent as much as it is feasible, the various political parties and shades of opinion represented in the National Assembly, gender and other special interest groups in that Partner State, in accordance with such procedure as the National Assembly of each Partner State may determine."

(ii) Paragraph 2 be rephrased to succinctly provide for the qualification for membership of the Assembly as below;

"A person shall be qualified to be elected a member of the National assembly of a Partner State if he:-

- (a) is a citizen of that Partner State;
- (b) has proven experience or interest in advancing the objectives of the Community;
- (c) is qualified to be elected a member of the legislature of Partner State under its electoral law;
- (d) is not a member of the National Assembly of that Partner State;
- (e) is not holding a political post as a Minister or Deputy Minister in that Partner State; and
- (f) is not an officer in the service of the Community or a servant of the East African Development Bank or of the other surviving institutions of the former East African Community."
- (iii) In view of the all-embracing provisions of Article 47 (2), paragraphs 3 and 4 of Article 46 should be deleted.

Article 48 - Questions as to membership of the Assembly

The Committee recommends that the Article be amended as follows:-

(i) Paragraph 1 be rephrased to read;

"Any question that may arise whether any person is an elected member of the Assembly shall be determined by the National Assembly of the Partner State responsible for the election in question and shall be communicated to the Clerk of the Assembly under certificate of the Clerk of that National Assembly for further action."

(ii) Paragraph 2 be deleted and be replaced by the following new Paragraph

"Any question that may arise touching on the membership of the Assembly including the cessation of membership by any elected member thereof under the provisions of Article 47 of this Treaty shall be communicated by the Clerk of the Assembly to the National Assembly concerned."

Article 49 - Speaker of the Assembly

The Committee recommends that the Article be amended as follows:-

(i) The name of the Chairperson should be "Speaker".

Accordingly, the term "Chairman of the Assembly" should, wherever it appears, be deleted and be replaced with the term "Speaker".

(ii) Paragraph 1 should be amended to read as follows:-

"The Speaker of the Assembly shall be elected by the elected members of the Assembly from among themselves to serve for a period of five years."

(iii) A new sub-paragraph 1 (b) should be inserted to be worded as follows:-

"A member of the Assembly elected to the office of Speaker of the Assembly shall automatically cease to be a member."

(iv) Paragraph 2(a) should be amended to expressly provide for a five year tenure of office.

Article 51 - Meetings of the Assembly

The Committee recommends that the Article be amended by deleting the word "Council" in both paragraphs 1 and 2 for appropriate replacement with the word "Assembly"

Article 54 - Voting in the Assembly

The Committee recommends that 54(1) be amended by deleting all the words immediately after the word "voting" in the second line.

Article 57 - Legislative functions of the Assembly

The Committee recommends that in view of the specific recommendation to amend Article 45 in the manner stipulated, this Article be deleted.

Consequently, the Articles should be renumbered.

CHAPTER NINE THE SECRETARIAT AND STAFF OF THE COMMUNITY

Article 64 - Functions of the Secretariat

The Committee recommends that a clear separation of roles be established between the Co-ordination Committee and the Secretariat particularly the harmonisation of Article 15(1)(d) with Article 64(1)(k) which appears to be in conflict.

CHAPTER TEN CO-OPERATION IN TRADE LIBERALIZATION AND DEVELOPMENT

Article 69 - Internal tariff

The Committee adopted this Article with the following reservations:-

- (i) In 69 (1), the period provided is not realistic.
- (ii) In 69 (2), the question of enforcement is pertinent.

Article 74 - Dumping

The Committee recommends that besides protocol detailing anti-dumping measures, institutional mechanisms to strengthen the Partner States capacity to stop dumping be established.

Article 82 - Duty Drawback

The Committee recommends that the concept of duty drawback be defined more explicitly to avoid ambiguity in interpretation.

CHAPTER TWELVE RE-EXPORTATION OF GOODS

Article 89 - General provisions

The Committee recommends that under the proviso of 89(1), a limit should be placed on administrative and service charges to avoid them being used as a replacement for import duty.

CHAPTER THIRTEEN SIMPLIFICATION AND HARMONIZATION OF TRADE DOCUMENTATION AND PROCEDURES

Article 91 - Trade documentation and procedures

The Committee recommends that the number of trade documentation and national bodies required to handle the documentation be reduced.

Article 92 - Trade facilitation

The Committee recommends that police road blocks be reduced to a bare minimum.

CHAPTER FOURTEEN MONETARY AND FINANCIAL CO-OPERATION

Article 95 - Monetary and fiscal policy harmonization

The Committee recommends that 95(2) be amended by inserting a new subparagraph (f) to provide for avoidance of double taxation.

Article 96 - Currency convertibility

The Committee recommends that the Partner States should work towards a return to a common currency as was the case during the defunct East African Currency Board.

Article 99 - Banking and Capital Market Development

The Committee recommends that this Article be amended by inserting the following two new sub-paragraphs to be worded as below;

- (i) 99(e), "ensure harmonisation of the Banking Acts, procedures and supervision."
- (ii) 99(f), "take measures to prevent money laundering activities."

Article 102 - Safeguard measures

The Committee recommends that:-

- (i) this Article be placed at the very end of the Treaty to address adverse effects emanating from implementation of the Treaty.
- (ii) the Article be harmonised with any other safeguard measures provided in the Treaty.

CHAPTER FIFTEEN CO-OPERATION IN INFRASTRUCTURE AND SERVICES

Article 103 - Common transport and communication policies

The Committee recommends that this Article be amended by deleting 103 (d).

The Committee also recommends that this Article be reworded to reflect the intended privatisation of some of these services.

Article 104 - Roads and road transport

The Committee recommends that 104(q) be amended by inserting the words "and standards" immediately after the word "policies" in the first line.

The Committee further recommends that rather than harmonizing policies, the Partner States should establish an East African Roads Authority to look after existing cross-border roads and establish new ones where necessary.

Article 105 - Railways and rail transport

The Committee recommends that the possibility of single entities taking over the privatised system should be explored.

Article 106 - Air transport

The Committee recommends that this Article be amended by deleting 106(1), (2) and (3)(b) and (i) in the light of the present privatisation realities.

Article 107 Maritime transport and ports

The Committee recommends that this Article be amended by deleting 107(q).

Article 108 Inland waterways transport

The Committee recommends that in the light of the proposed privatisation, the Article should be reviewed.

Article 110 Freight booking centres

The Committee recommends that this Article be deleted.

Article 111 Freight forwarders, customs clearing agents and shipping agents

The Committee recommends that this Article be amended as follows:-

(i) That 111(1) be rephrased to read;

"The Partner States shall allow any person to register, and be licensed, as a freight forwarder, customs clearing agent and shipping agent, provided that, that person fulfils the harmonized legal requirements of the Partner States."

(ii) That 111(2) be deleted in view of the stipulated amendment to Article 112

Article 112 - Postal Services

The Committee recommends that this Article be amended as follows:-

- (i) a semi-colon be inserted immediately after the word "Community" in the fifth line.
- (ii) the word "including" in the fifth line be deleted and the words "and adopt compatible policies regarding", be inserted in place thereof.

Article 113 - Telecommunications

The Committee recommends that be amended by deleting the word "shall" in the second line.

CHAPTER SEVENTEEN FREE MOVEMENT OF PERSONS, LABOUR, SERVICES, RIGHT OF ESTABLISHMENT AND RESIDENCE

Article 118 - Scope of Co-operation

The Committee recommends that the possibility of establishing an East African Industrial Court should be explored.

CHAPTER EIGHTEEN AGRICULTURE AND FOOD SECURITY

Article 119 - Agriculture and food security

The Committee recommends that this Article be amended as follows:-

(i) 119(1)(c) be reworded to read;

"an increase in the productivity and efficiency in storage of crops, livestock fisheries and forest products for domestic consumption, exports within and outside the community and as inputs to agro-based industries within the Community".

(ii) 119 (2)(e) be rephrased to read;

"standardisation in the manufacture of food products to meet internationally accepted quality and environmental standards".

CHAPTER NINETEEN CO-OPERATION IN ENVIRONMENT AND NATURAL RESOURCES

Article 120 - Environmental issues and natural resources

The Committee recommends that this Article be amended by rephrasing 120 (6)(b)(c) and (d) as below:

(i) 120 (6)(b) to read;

"to jointly enhance the institutional capacity to manage toxic waste; and"

(ii) 120(6)(c) to read;

"to ensure sustainable utilization of natural resources within the diverse ecosystems such as lakes, wetlands, forests and range lands".

(iii) 120 (6)(d) to read;

"to jointly develop and adopt sustainable water resource use, management and conservation policies".

Article 121 - Management of the Environment

The Committee recommends that 121(2)(n) be amended to read;

"adopt common policies and regulations governing the use and management of genetic resources".

Article 122 - Prevention of illegal trade and movement in toxic chemicals, substances and hazardous wastes

The Committee recommends that this Article be amended as follows:-

(i) That the heading be reworded to read;

"Prevention of illegal trade in and movement of toxic chemicals, substances and hazardous wastes."

(ii) That 122(3) be rephrased to read;

"The Partner States undertake to accede to and ratify international environmental conventions that are designed to conserve the environment and improve environment and improve environmental policies and management".

CHAPTER TWENTY CO-OPERATION IN TOURISM AND WILDLIFE MANAGEMENT

Article 124 - Tourism and Wildlife management

The Committee recommends that the Article be amended as follows:-

(ii) 124(3)(e) be rephrased to read;

"take measures to ratify and accede to and ratify, and, implement relevant international conventions, and"

CHAPTER TWENTY ONE CO-OPERATION IN HEALTH, SOCIAL AND CULTURAL ACTIVITIES

Article 125 - Health, social and cultural activities

The Committee recommends that the Article be amended as below:-

- (i) 125(2)(a) be rephrased to read;
 - "take joint action on agreed public health interventions for disease prevention and control."
- (ii) 125(2) be amended by inserting the following new sub-paragraphs to be

listed and worded;

- (j) "co-operate in the promotion of maternal and child health and access to health care.
- (k) co-operate in the promotion of adolescent health and access to health care.
- (I) co-operate in the development and promotion of access and health care to the aged."

CHAPTER TWENTY TWO ENHANCING THE ROLE OF WOMEN IN SOCIO-ECONOMIC DEVELOPMENT

Article 126 - The role of women in socio-economic development

The Committee recommends that this Article be amended as follows:-

- (i) the word "agree" in the first line be deleted and the word "recognize" be inserted in place thereof.
- (ii) 126(a) be rephrased to read;

"promote the empowerment and effective integration and participation of women at all levels of development especially in decision-making".

Article 127 - Role of women in business

The Committee recommends that this Article be amended as follows:-

- (i) Under 127(a), the words "formulation and implementation" be inserted immediately after the word "policy"
- (ii) 127 (c) be rephrased to read;

"promote special programmes for women in small, medium and large size enterprises".

(iii) 127 (d) be rephrased to read;

"eliminate such laws, regulations and practices that hinder women's access to credit".

CHAPTER TWENTY THREE CO-OPERATION IN INVESTMENT AND INDUSTRIAL DEVELOPMENT

Article 128 - Industrial Development

The Committee recommends that this Article be amended by deleting 128(1)(a).

Article 129 - Strategy and priority areas

The Committee recommends that 129 (1)(e) be amended by inserting the words "establishment and" immediately before the word "promotion" and that the word "and" in the first line be deleted and the word "facility" be inserted in place thereof.

The Committee further recommends that deliberate action should be taken to make the provisions of this Article workable.

CHAPTER TWENTY FOUR CO-OPERATION IN STANDARDIZATION AND QUALITY ASSURANCE

The Committee recommends that this Chapter be amended as follows:-

(i) The heading of the Chapter be rephrased to read;

"Standardisation, Metrology, Quality Assurance, Quality Management and Accreditation"

(ii) Article 130 be deleted and be replaced with the following Articles which should be numbered as appropriate:-

Article - Role of Standardisation, Metrology, Quality Assurance and Quality Management.

The member states, recognising the importance of Standardisation, metrology, Quality Assurance and Quality Management in the promotion of health, the enhancement of the standards of living, the rationalisation and reduction of unnecessary variety of products (goods and services), the facilitation of interchangeability of products, the promotion of trade, consumer protection, the creation of savings in Government purchasing, improved productivity, the facilitation on information exchange as well as in the protection of life, property, and the environment, agree to:

evolve and apply a common policy with regard to the standardisation and quality assurance of products produced and traded within the East African, the relationship of their national standards bodies with regional, international and other organisations concerned with standardisation and quality assurance

- and in the development of activities in standardisation and quality assurance for the achievement of the objectives of the East African market.
- (b) promote activities of the national standards bodies and develop their technical capacities so as to enable them to adequately carry out standardisation and quality assurance activities at the national level and to cooperate with other member states and other relevant bodies.
- (c) promote and enforce standards relating to public health and safety and the protection of the environment by applying appropriate standards for products produced and traded within East Africa; and
- (d) recognise the standards developed and adopted by the African Regional Organisation for Standardisation (ARSO) as leading co-operating partner in the implementation of appropriate provisions of this Chapter and agree to accede to the Agreement establishing ARSO.

Article - Establishment of Standards

The member states undertake to:

- (a) apply uniform rules and procedures for the formulation of their national standards.
- (b) adopt African regional standards and where these are unavailable, adopt suitable international standards for products traded in East Africa.
- (c) co-ordinate their views with regard to the selection, recognition, adaptation and application of East African Standards and International Standards in so far as the needs of the East African are concerned, and constantly endeavour to improve the standardisation of products within the East African region.
- (d) apply the principle of reference to standards in their national regulations, so as to facilitate the harmonisation of their technical regulations.

Article - Quality Assurance and Quality Management

The member states shall:

- (a) apply uniform standards and specification for the inspection and testing of products traded within East Africa, so that the results may be more easily interpreted and co-ordinated in a similar manner within the East African region.
- (b) adopt regionally acceptable quality management and quality assurance standards and develop capacities for assuring quality of products traded in East Africa.

- (c) use harmonised documentation for the evaluation of the quality of products traded in East Africa; and
- (d) in conjunction with customs and other relevant authorities, provide for ease of movement of samples meant for testing within East Africa.

Article - Environment

Member states shall:

- (a) develop and harmonise Environmental Standards within East Africa.
- (b) adopt International Standards and use them to promote environmental requirements of products produced within East Africa.

Article - Certification and Laboratory Accreditation

The member states shall:

- (a) adopt and apply a harmonised scheme for the certification of products produced and traded in East Africa.
- (b) adopt and apply a harmonised scheme for the accreditation of laboratories used for the evaluation of products produced and traded in East Africa and for the mutual recognition of each others national certification marks and laboratory accreditation schemes.

Article - Metrology

The member states shall:

- (a) adopt a harmonised system for legal, scientific and industrial metrology activities and formulate modalities for the mutual recognition of calibration certificates issued by the national metrology laboratories and accredited calibration centres within the member states.
- (b) promulgate national legal frameworks for legal metrology in line with International Organisation for Legal Metrology (OIML) guidelines.
- (c) adopt and systematically apply a uniform system of labelling products to be traded within East Africa.
- (d) agree to standardise all aids to the recognition and movement of goods and their containers such as labels and transit documents.
- (e) apply safety codes for the handling and shipment of products traded within

East Africa.

(f) in conjunction with customs and other relevant authorities, provide for the ease of movement of metrology standards and equipment sent for calibration within the member states.

Article - Co-operation in Testing

The member states undertake to encourage inter-laboratory comparison testing, establish competence of repeatability and reproducibility of results promoting recognition of test certificates within the region.

Article - Documentation and Information

The member states shall agree to adopt compatible management systems for standardisation, quality assurance and quality management related documentation and information to facilitate easier exchange of information among themselves.

Article - Training

The member states agree to:

- (a) consult one another through the Secretariat, concerning their common training needs in the field of standardisation, quality assurance, testing and metrology.
- (b) undertake to co-ordinate among themselves the use of existing facilities with a view to making them accessible to other member states.
- (c) establish in conjunction with the ARSO and other relevant organisations, training programmes designed to meet the specific needs of the East African market.

Article - Publicity

The member states shall endeavour to make all the activities of standardisation, metrology, testing, quality assurance and quality management to all concerned through seminars, advertisements, publications, films, discussions, participation of the national standardisation institutions in trade fairs, special national awards and the creation of national quality associations within the member states.

Article - Administrative Procedures

The member states shall use harmonised documentation for the evaluation of the quality of goods for customs clearance of goods traded in the East African market.

Article - Accreditation

The member states shall undertake and establish an East African Accreditation Body to promote recognition of certification and test laboratories within the region and worldwide.

The member states shall use harmonised documentation for evaluation quality of goods for customs clearance for goods traded in the East African market.

CHAPTER TWENTY FIVE CO-OPERATION IN POLITICAL MATTERS

Article 132 - Regional peace and security

The Committee recommends that this Article be amended by inserting a new paragraph (5) to read:-

"Partner States undertake to co-operate in reviewing the region's security particularly on the threat of terrorism and formulate security strategies and measures to combat terrorism".

Article 133 - Defence

The Committee recommends that 133(2)(b) be amended by inserting the word "of" immediately after the word "fields".

CHAPTER TWENTY SEVEN CO-OPERATION IN OTHER FIELDS

Article 135 - Other fields

The Committee recommends that this Chapter should be swapped with Chapter Twenty Nine and the Articles renumbered accordingly.

CHAPTER TWENTY EIGHT THE PRIVATE SECTOR AND THE CIVIL SOCIETY

Article 136 - Creation of an enabling environment for the private sector

The Committee recommends that 136(2)(b) be rephrased to read:-

"stimulate market development through infrastructural linkages and the removal of unnecessary barriers and constraints to market development;"

Article 137 - Strengthening the private sector

The Committee recommends that this Article be amended as follows:-

(i) 137(2)(a) be rephrased to read;

"encourage the efficient use of scarce resources and to promote the development of private sector organisations which are engaged in all types of economic activity such as, the chambers of commerce, confederations and associations of industry, agriculture, manufacturers, farmers and professional development groups;".

(ii) 137(2)(c) be rephrased to read;

"establish a quality information system which will allow collection, harmonised processing and timely dissemination of data and information."

The Committee recommends that this Article be amended as follows:-

(i) That 142(1) be rephrased to read;

"There shall be an East African Audit Commission made up of the Auditors General of Partner States whose functions will be to audit the accounts of the Community"

(ii) That 142 (3) be rephrased to read;

"The Audit Commission shall submit its reports under paragraph 2 of this Article to the Council within six (6) months after the end of each financial year which shall cause the same to be laid before the Assembly and for such other consideration and action as the Council may deem necessary".

CHAPTER EIGHT

THE EAST AFRICAN COMMUNITY ASSEMBLY

The Committee agreed with the proposal advanced by the East African Co-operation meeting of Speakers of the National Assemblies in Arusha, 1998;

That the Assembly be called the "East African Legislative Assembly" instead of the "East African Community Assembly"

Accordingly, the name should be changed in Chapters Three, Eight and wherever it appears in the draft Treaty.

Article 44 - Composition of the East African Legislative Assembly

The Committee agreed with the proposal advanced by the East African Co-operation Meeting of Speakers of the National Assemblies in Arusha, 1998;

- (i) 44 (1) (a), That the membership of the Assembly be revised from twenty seven elected members to forty five.
- (ii) 44(4), That the words "on the recommendation of the Assembly" be inserted immediately after the word "shall" in the first line.

Article 45 - Functions of the Assembly

The Committee agreed with the proposal advanced by the East African Co-operation meeting of Speakers of the National Assemblies in Arusha, 1998 that;

Paragraphs 1 and 2 be deleted and be replaced by the following 3 paragraphs.

- 1. "Subject to the provisions of this Treaty, the community may through its Assembly, enact measures to which legislative effect may be given in the Partner States with respect to such matters as the Summit may from time to time, determine.
- 2. The Assembly may discuss any matter pertaining to the Community.

3. The Assembly shall liaise with the legislatures of the Partner States on matters pertaining to the Community."

Consequently, Article 57 should be deleted.

Article 46 - Election of members of the Assembly

The Committee agreed with the proposal by the East African Co-operation meeting of Speakers of the National Assemblies in Arusha, 1998, that;

(i) Paragraph 1 be rephrased to read as follows.

"The National Assembly of each Partner State shall elect fifteen members for the Assembly, who shall represent as much as it is feasible, the various political parties and shades of opinion represented in the National Assembly, gender and other special interest groups in that Partner State, in accordance with such procedure as the National Assembly of each Partner State may determine."

(ii) Paragraph 2 be amended to succinctly provide for the qualification for membership of the Assembly as follows.

"A person shall be qualified to be elected a member of the National assembly of a Partner State if he:-

- (a) is a citizen of that Partner State;
- (b) has proven experience or interest in advancing the objectives of the community;
- (c) is qualified to be elected a member of the legislature of Partner State under its electoral law;
- (d) is not a member of the National Assembly of that Partner State;
- (e) is not holding a political post as a Minister or Deputy Minister in that Partner State; and
- (f) is not an officer in the service of the Community or a servant of the East African

Development Bank or of the other surviving institutions of the former East African Community."

(iii) In view of the all-embracing provisions of Article 47(2), paragraphs 3 and 4 of Article 46 should be deleted.

Article 47 - Tenure of office of elected Members

The Committee deliberated on this Article and deferred it pending consultations with the legislators of the other Partner States and the Secretariat of the Permanent Tripartite Commission.

Article 48 - Questions as to membership of the Assembly.

The Committee agreed with the proposal by the East African Co-operation meeting of Speakers of the National Assemblies in Arusha, 1998 that;

(i) Paragraph 1 be amended to read as follows:

"Any question that may arise whether any person is an elected member of the Assembly shall be determined by the National Assembly of the Partner State responsible for the election in question and shall be communicated to the Clerk of the Assembly under certificate of the Clerk of that National Assembly for further action."

(ii) Paragraph 2 be deleted and be replaced by the following new Paragraph

"Any question that may arise touching on the membership of the Assembly including the cessation of membership by any elected member thereof under the provisions of Article 47 of this Treaty shall be communicated by the Clerk of the Assembly to the National Assembly concerned."

Article 49 - Speaker of the Assembly

The Committee agreed with the proposal by the East

African Co-operation meeting of Speakers of the National Assemblies in Arusha, 1998 that;

(i) The name of the Chairperson should be "Speaker".

Accordingly, the term "Chairman of the Assembly" should, wherever it appears, be deleted and be replaced with the term "Speaker".

(ii) Paragraph 1 should be amended to read as follows:-

"The Speaker of the Assembly shall be elected by the elected members of the Assembly from among themselves to serve for a period of five years."

(iii) A new sub-paragraph (b) should be inserted to be worded as follows:-

"A member of the Assembly elected to the office of Speaker of the Assembly shall automatically cease to be a member."

(iv) Paragraph 2(a) should be amended to expressly provide for a five year tenure of office.

Article 50 - Invitation of persons to assist the Assembly

The Committee agreed with the proposal by the East African Co-operation meeting of Speakers of the National Assemblies in Arusha, 1998 that the word "Informal" in Paragraph 2 be deleted.

Article 51 - Meetings of the Assembly

The Committee agreed with the proposal by the East African Co-operation meeting of Speakers of the National Assemblies in Arusha, 1998 that the word "Council" in both Paragraph 1 and 2 should be deleted for appropriate replacement with the word "Assembly".

Article 52 - Presiding in the Assembly

The Committee considered and adopted this Article.

The members expressed concern that the apparent grey areas created by the Paragraphs could be exploited to the detriment of the community.

The Minister promised to review the wording to seal any loopholes.

CHAPTER TWELVE

Article 89 (1)

The Committee recommended that in order to curtail dumping and tax evasion, duty should be levied at the port of entry or at source and reimbursed later upon certification that the goods were actually exported.

The Minister proposed that this matter be raised with the Minister for Finance who deals with revenue.

CHAPTER THIRTEEN

The Committee recommended that the number of trade documentation and national bodies required to handle the documentation be reduced.

The Minister undertook to take this proposal on board.

CHAPTER FOURTEEN

Article 95

The Committee recommended that Paragraph 2 be amended by inserting a new sub-paragraph (f) to provide for avoidance of double taxation so that a person who is taxed in any Partner State outside his country is not taxed at home.

Article 96

The Committee recommended that the Partner States should work towards a return to a common currency as was the case during the defunct East African Currency Board.

The Minister pointed out that the initial objective of the Community was to harmonise policies within the Partner States before establishing common services unions.

CONCLUSION

The Minister emphasized that there is political will within the leadership of the Partner States and is totally committed to the creation of a lasting co-operation.

 - (i) co-operate in the promotion of development of good nutritional standards and the popularization of indigenous foods.

- (j) develop a common approach to address the trafficking and consumption of illicit and banned drugs.
- (ii) In 125(3)(a), a comma be inserted after the word "employment".

ENHANCING THE ROLE OF WOMEN IN SOCIO-ECONOMIC DEVELOPMENT
