

CHAIRPERSON'S FOREWORD

The Parliamentary Service Commission is established under Article 127 of the Constitution of Kenya (2010). The Article mandates the Commission to provide services and facilities to ensure that there is efficient and effective functioning of Parliament. Further, Article 127 (6) (e) confers the Commission the duty of carrying out activities that are necessary for the well-being of the Members of Parliament both in their Nairobi and constituency offices.

The National Assembly Standing Order 212B established the Committee on Members' Services and Facilities, which is one of the Sessional Committees of the House, responsible for receiving and considering views of Members on the services and facilities provided for their benefit and well-being. The Committee is also mandated to advise and report on all matters relating to the services and facilities provided for Members.

The Committee undertook inspection visits to selected Constituencies and County Women Representative offices in the Counties of Kilifi, Kwale, Mombasa, Laikipia, Nyandarua and Machakos. The objective of the visit was to establish the status of the quality of services and facilities extended by the Commission to the serving Members of Parliament and their constituents.

The Committee observed that emoluments of staff working at the Constituency offices were not enhanced and there was no annual salary increment despite provision of the same in their contracts. The Committee also observed that staff at the Constituency offices lacked requisite training to enhance their skills and competencies.

The Committee recommends that emoluments of staff working at the Constituency offices should be enhanced by the Parliamentary Service Commission (PSC) to cushion the staff from the ever-escalating cost of living and to motivate them adequately.

The Committee also recommends PSC should, through the Centre for Parliamentary Studies and Training, organize for seminars and workshops and develops a curriculum for continuous training and capacity building for all staff of the constituency offices of Members.

May I take this opportunity to thank all Members of the Committee for their contributions and input during the deliberations and writing of this report. The Committee also wishes to thank the offices of the Speaker and the Clerk of the National Assembly for the logistical support provided during the inspection visits.

1.0 PREFACE

1.1 Committee Mandate

- Article 127 (6) of the Constitution of Kenya mandates the Parliamentary Service Commission to among others provide services and facilities to ensure efficient and effective functioning of Parliament. Further Article 124 of the Constitution empowers Parliament to establish committees.
- 2. The Committee on Members' Services and Facilities is established under Standing Order 212B and is responsible for
 - a) Receiving and considering views of Members on the services and facilities provided for their benefit and well-being; and
 - Advising and reporting on all matters connected to the services and facilities provided for Members.
- 3. In this regard, the oversight role over facilities for use by Members and staff of the National Assembly are within the mandate of the Committee.
- 4. The Committee is therefore a formal forum through which the Members of the National Assembly channel views regarding their welfare to the Commission. The Committee executes its mandate through:
 - a) Benchmarking visits to other jurisdictions to establish new ideas and practices;
 - b) Undertaking inspection visits to the Constituency and County offices for Members; and
 - c) Direct contact with Members of Parliament to receive their concerns and complaints.

The Committee on Members' Services and Facilities Report on Inspection Visit to Constituency Offices.

2.0 BACKGROUND

- 7. The Parliamentary Service Commission is amongst the constitutional commissions established under Article 127 of the Constitution of Kenya. Its responsibility includes provision of services and facilities to ensure effective and efficient working of Parliament and other functions that are necessary for the well-being of the Members and Staff.
- 8. The Commission extends an array of services to Members such as medical services, insurance services, security services, and library and information services.
- 9. The National Assembly Standing Order 212B establishes the Select Committee on Members' Services and Facilities that is mandated to receive and consider the views of Members of the National Assembly on the services and facilities extended to them by the Commission for their benefit and well-being. The Committee is also given the mandate to advise and report on all matters relating to the services and facilities. The Committee, therefore, is the forum through which the Members of the National Assembly channel their views and concerns regarding their welfare provided by the Commission.
- 10. The Committee oversees the facilities available to Members including but not limited to, parliament buildings, the health club at Parliament, the constituency and county offices for Members of the National Assembly, the quality of catering services in Parliament, and works proactively to ensure upcoming buildings cater for Members' needs and meet their expectations.
- 11. The Committee also ensures that the emoluments of Members of Parliament and staff, both in the Nairobi and constituency offices, are processed on time.
- 12. Previously, matters of Members' welfare were handled informally through the *Speaker's Kamukunji*, and due to that backdrop, the Committee was established to create a forum through which such matters could be handled. Therefore, this formalizes the deliberations on matters of interest to Members and provides a channel through which the issues raised by Members can find their way to the House by way of a report.
- 13. The objectives of the inspection visits were to: -
- i). Collect views and assess the quality of services & facilities and status of office infrastructure;
- ii). Determine status of constituency/county staff salaries disbursement by the Parliamentary Service Commission and adherence to statutory remittances;
- iii). Understand challenges experienced by staff while undertaking their roles;
- iv). Provide an opportunity for the Constituency staff to apprise the Committee on possible solutions that should be provided by the Parliamentary Service Commission for effective and efficient service delivery by Members, and recommend areas of improvement.
- 14. This report therefore highlights the scenarios in the constituency/county offices of Members visited in terms of the staff establishment, the challenges the staff faced while executing their duties, and recommendations to address the said challenges.

3.0 INSPECTION VISIT TO CONSTITUENCY AND COUNTY OFFICES

17. The Committee undertook an inspection visit in Kilifi and Kwale Counties on Friday, 14th April, 2023 and in Mombasa County on Saturday, 15th April, 2023. The Committee also visited Machakos County on Friday, 4th August, 2023 and the Counties of Laikipia and Nyandarua on Friday, 1st and Saturday, 2nd December, 2023 respectively.

3.1 KILIFI COUNTY

18. The Committee visited the Constituencies/County offices in Kilifi on Friday, 14th April, 2023. The inspection visits commenced with the office of the Kilifi South Constituency in Vipingo town, followed by a courtesy call to the County Commissioner's office and later to the office of the Kilifi North Constituency. Further, the Committee visited the office of the County Woman Representative and concluded the inspection at the Malindi Constituency office.

Remarks by the County Commissioner, Kilifi County

- 19. The delegation led by the Chairperson paid a courtesy call to the Kilifi County Commissioner Mr. Josphat Biwott on Friday, 14th April, 2023. The Chairperson briefed the sitting on the mandate of the Committee and the rationale behind the inspection visits and the expected outcomes.
- 20. The Commissioner thanked the Committee and apprised Members on the challenge concerning NG-CDF staff. There were concerns over the continuity of staff in NG-CDF and constituency offices since staff are recruited after every term of Parliament, resulting into lack of institutional knowledge, leading to disgruntled constituents due to the frequent changes of staffers.

3.1.1 Kilifi South Constituency

21. The Chairperson briefed the sitting on the mandate of the Committee and the rationale for the inspection visit. He then invited the constituency office staff to brief the delegation on the staff, facilities and challenges at the office.

Submissions by the Office Manager for the Kilifi South Constituency

- 22. The Constituency Office Manager, Mr. Ferdinand Yawa, who was accompanied by other staff, briefed Members. The Manager noted improvement on payment of salaries for the constituency office staff that was paid on monthly basis compared to the previous quarterly payments. The Manager thanked the Committee and the PSC for effecting the changes that enabled them secure loan facilities as a result.
- 23. The delegation was further informed that the office faced the following challenges:
 - a) Statutory deductions problems especially with regard to NSSF dating back to the 11th Parliament office that had not been remitted as required

- b) Frequent queries and penalties for non-compliance to National Hospital Insurance Fund (NHIF) and National Social Security Fund (NSSF) timelines and regulations occasioned by delayed salaries
- c) Huge pending statutory deductions and penalties on non-remittances to KRA and NSSF had led to some of the staff not being paid gratuities after serving in the 12th Parliament until the penalties and deductions were paid
- d) Delay in payment of staff salaries There was need to ensure that staff at the constituency office are paid by the 2nd day of every month
- 24. Members observed that the Ksh.150,000.00 meant to cater for late penalties addressed some of the challenges the constituency faced.
- 25. The delegation proposed that the office management should look into repainting the office building with funds from operations or with the landlord so as to give the office of the Member of Parliament a decent image.

3.1.2 Kilifi North Constituency

- 26. The Committee visited the Office of the Member of Parliament for Kilifi North Constituency, Hon. Owen Baya, MP, CBS, and Deputy Leader of Majority Party on Friday, 14th April 2023 at 11.00 a.m. The officers led by the Office Manager, Mr. Emmanuel Nyongo, received the delegation.
- 27. The Chairperson briefed the sitting on the mandate of the Committee and the rationale for the inspection visit. He then invited the constituency office staff to engage the delegation on the staff, facilities, and challenges at the office.
- 28. The Office Manager informed Members of the following challenges:
 - a) There was no training for the constituency office staff but instead an induction programme was organized for the office Manager and Personal Assistant; the other staff were unaware of their job descriptions and roles. The committee noted the need to organize training for all constituency office staff
 - b) The accounting practices associated with the Constituency Liaison office were tedious, voluminous and subject to misplacement/loss. The committee noted the need to intervene and fast-track automation initiatives
 - c) The constituency office staff registered their complaints that there were delays in processing gratuities
 - d) There were still handing over challenges that led to penalties and huge pending bills on KRA, NHIF and NSSF statutory deductions
- 29. The Committee visited the Ajira Training Center facility located within the Office's premises and lauded the area MP for giving young people an opportunity to develop their ICT skills.
- 30. Kilifi North Constituency is vast leading to administration challenges it was proposed that PSC needed to facilitate Members to have additional satellite offices at vast constituencies to enhance operations and better facilitation of the constituents.

3.1.3 Office of the County Woman Member of Parliament - Kilifi County

- 31. The delegation visited the office of the Woman Member of Parliament for Kilifi County Hon. Gertrude Mbeyu Mwanyanje, MP on Friday, 14th April 2023, and were received by the Office Manager Mrs. Valdy Mwashigadi.
- 32. The Chairperson briefed the sitting on the mandate of the Committee and the rationale for the inspection visit. He then invited the office staff to brief the delegation on the staff, facilities, and challenges at the office.
- 33. The Office Manager Mrs. Valdy Mwashigadi informed Members of the following challenges:
 - a) Pending remittances from the 12th Parliament and delayed remittances of statutory deductions led to penalties for the office.
 - b) Slow response and feedback from the Parliament's Constituency Liaison office which caused various delays such as payments and inefficiencies in office operations.
 - c) There was delay in processing of gratuity and leave allowances.

3.1.4 Malindi Constituency

- 34. The delegation visited the office of the Member of Parliament for Malindi Constituency Hon. Amina Mnyazi, MP. A team of officers led by the Constituency Office Manager Mr. Jumaa Kazungu received the Committee.
- 35. The Chairperson briefed the Constituency office staff on the mandate of the Committee and the rationale for the inspection visit. He then invited the constituency office staff to brief the delegation on the staff, facilities, and challenges at the office.
- 36. The Constituency Office Manager Mr. Jumaa Kazungu informed Members of the following challenges:
 - a) The operations fund was received towards the end of the quarter thus affecting office operations and payments of suppliers for services provided. There was need to release the money on monthly basis to enhance office operations
 - b) The medical insurance provided by NHIF was not adequate. There was need to elevate the NHIF cover for the constituency staff to the level of civil servants
 - c) There was no induction and training programme for the constituency office staff leading to challenges in performance of duties

3.2 KWALE COUNTY

37. The Committee visited the Constituencies/County offices in Kwale County on Friday, 14th April, 2023. The inspection visit commenced with courtesy call to the Office of the County Commissioner who apprised the Committee on the state of affairs in the region.

3.2.1 Office of the County Woman Member of Parliament - Kwale County

- 38. The delegation visited the office of the Woman Member of Parliament for Kwale County, Hon. Fatuma Masito, M.P. on Friday, 14th April, 2023 and were received by the Office Manager Mr. Ali Salim Shufa.
- 39. The Chairperson briefed the sitting on the mandate of the Committee and the rationale for the inspection visit. He then invited the office staff to brief the delegation on the staff, facilities, and challenges at the office.
- 40. The Office Manager Mr. Ali Salim Shufa apprised the Committee on the following challenges:
 - a) The NHIF cover was discriminatory as the constituency office pays a premium similar to that of civil servants but does not enjoy similar access to treatment
 - b) There was no induction and training programmes and the staff lacked knowledge on their roles and responsibilities

3.2.2 Msambweni Constituency

- 41. The delegation visited the office of the Member of Parliament for Msambweni Constituency Hon. Feisal Bader, MP, who is also the Vice-Chairperson of the Committee. The Constituency Office Manager, Mr. Abasi Mahaba, accompanied by other staff received the delegation.
- 42. The Chairperson briefed the sitting on the mandate of the Committee and the rationale for the inspection visit. He then invited the constituency office staff to brief the delegation on the staff, facilities, and challenges at the office.
- 43. The Constituency Office Manager, Mr. Abasi Mahaba informed Members of the following challenges:
 - a) Delayed salaries for constituency staff and disbursement of funds for office rent and operations occasioned by late release of funds
 - b) Frequent queries and penalties for non-compliance to KRA, NHIF and NSSF timelines and regulations
 - c) There was need to review NHIF medical cover to comprehensively cater for the staff at the constituency office
 - d) There was no induction and trainings for staff at the constituency office to equip them with requisite skills and knowledge. Currently, it is only the Constituency Office Managers who undertakes induction programmes.

3.3 MOMBASA COUNTY

44. The Committee visited the County of Mombasa on Saturday, 15th April, 2023. The inspection visit commenced with a courtesy call to the Office of the County Commissioner, who apprised the Committee on the state of affairs in the region.

3.3.1 Likoni Constituency

- 45. The delegation led by the Chairperson visited the Office of Likoni Constituency Hon. Mishi Juma Mboko, MP, on Saturday, 15th April, 2023. The Constituency Office Manager Mr. Mohamed Salim Nyembwe accompanied by other office staff received the delegation.
- 46. The Chairperson briefed the sitting on the mandate of the Committee and the rationale for the inspection visit. He then invited the constituency office staff to brief the delegation on the staff, facilities, and challenges at the office.
- 47. The Constituency Office Manager Mr. Mohamed Salim Nyembwe apprised Members of the following challenges:
 - a) Delayed disbursement of salaries for constituency staff

b) Frequent queries and penalties for non-compliance to KRA, NHIF and NSSF timelines and regulations

- c) High rent leases for the office
- d) The office inherited huge KRA pending bill of close to Ksh. 6,000,000.00

3.3.2 Office of the County Woman Member of Parliament - Mombasa County

- 48. The delegation visited the office of the Woman Member of Parliament for Mombasa County on Saturday, 15th April, 2023. The Hon. Zamzam Mohamed, MP, accompanied by her office staff, received the delegation.
- 49. The Chairperson briefed the sitting on the mandate of the Committee and the rationale for the inspection visit. He then invited the office staff to brief the delegation on the staff, facilities, and challenges at the office.
- 50. The officers led by the Office Manager Mrs. Irene Cherotich informed Members of the following challenges:
 - a) Lack of furniture and Information and Communication Technology (ICT) related facilities; a problem escalated from the management of the previous government
 - b) The need for benchmarking, training and capacity buildings programmes for the staff to enable them execute their mandate effectively

3.3.3 Nyali Constituency

- 51. In Nyali Constituency office, a team of officers led by the Constituency Office Manager, Mrs. Everline Atieno Aluoch, received the Committee.
- 52. The Chairperson briefed the sitting on the mandate of the Committee and the rationale for the inspection visit. He then invited the constituency office staff to brief the delegation on the staff, facilities, and challenges at the office.
- 53. The Constituency Office Manager, Mrs. Everline Atieno Aluoch informed Members of the following challenges:
 - a) Lack of a comprehensive NHIF cover for the constituency office staff

 b) Too much paperwork that leads to possibilities of error and delay of funds release to the constituency office. The Constituency Liaison Office to fast track digitization of records and automation of returns

3.3.4 Kisauni Constituency

- 54. In the Kisauni Constituency office, a team of officers led by the area Member of Parliament Hon. Rashid Bedzimba, MP accompanied by constituency staff received the Committee.
- 55. The Chairperson briefed the sitting on the mandate of the Committee and the rationale for the inspection visit. He then invited the constituency office staff to brief the delegation on the staff, facilities, and challenges at the office.
- 56. The Constituency Office Manager Mr. Abdulghany Jadeed informed Members of challenges such as:
 - a) Delays in funds disbursement to the constituency which led to penalties by KRA, NSSF and NHIF
 - b) Too much paperwork that leads to possibilities of error and delay in release of funds to the constituency office
 - c) Lack of adequate office furniture

3.4 LAIKIPIA COUNTY

57. The Committee visited the County of Laikipia on Friday, 1st December, 2023. The inspection visits commenced with a courtesy call to the Deputy County Commissioner's office and later to the office of the Laikipia West Constituency.

Remarks by the Deputy County Commissioner, Laikipia

- 58. The delegation led by the Chairperson paid a courtesy call to the Deputy County Commissioner, Ms. Anne Mitema and informed her of the purpose of the visit.
- 59. The Chairperson briefed the sitting on the mandate of the Committee and the rationale for the inspection visits and the expected outcomes.
- 60. The Deputy County Commissioner thanked the Committee and appraised Members on the basic information concerning the sub-county and challenges concerning her office and the execution of its mandate.

3.4.1 Laikipia West Constituency

- 61. The Chairperson briefed the sitting on the mandate of the Committee and the rationale for the inspection visit. He then invited the constituency office staff to brief the delegation on the staff, facilities, and challenges at the office.
- 62. The Constituency Office Manager, Mr. Cyrus Mugweru, accompanied by other staff thanked the delegation for the visit and informed the Committee of the following:
 - a) There was improvement on payment of salaries for the constituency staff as they were being paid on monthly basis compared to the previous quarterly payments of salaries

- b) There is no training provided for PSC staff at the constituency office. The Committee noted that while NG-CDF staff enjoy training, the same is not extended to constituency staff
- c) Lack of enough ICT infrastructure at the constituency office
- d) Lack of transport facilitation for staff and the need to have a car for office operations
- 63. The constituency staff requested for monthly release of office operations funds as is the case with salaries.
- 64. The Committee urged the Constituency Office Manager to file and submit returns of operations fund and salaries on time.
- 65. The Committee noted the need to tap internet connectivity from the proposed ICT hub set up in various wards within the constituency to address the problem of internet connectivity.

3.5 NYANDARUA COUNTY

66. The Committee undertook an inspection visit to Ol Jorok and Ol Kalou Constituency offices in Nyandarua County on Saturday, 2nd December, 2023.

3.5.1 Ol Jorok Constituency

- 67. The delegation visited the Office of the Member of Parliament for Ol Jorok Constituency on Saturday, 2nd December, 2023 at 10.00 a.m. A team of officers led by the Personal Assistant to the area Member of Parliament, Mr. James Mwangi and the Constituency Office Manager, Mrs. Alice Murage received the Committee.
- 68. The Chairperson briefed the sitting on the mandate of the Committee and the rationale for the visit. He then invited the constituency office staff represented by a team of five senior officers to brief the delegation on the staff, facilities, and challenges at the office.
- 69. The constituency office staff thanked the Committee for the monthly release of salaries for the staff by PSC and the Ksh. 150,000.00 to cushion the office against penalties on late remittances of statutory deductions. They however reiterated that the money is not adequate to cover the delays in release of funds to the constituencies.
- 70. The Constituency Office Manager Mr. James Mwangi informed Members of the following:
 - a) There is no annual salary increment despite the provision of the same in contracts
 - b) The NHIF cover should be enhanced for the staff to get better services. The cover offers services equivalent to Ksh. 500.00 monthly contribution while the premiums that staff were charged were more than the cover provided
 - c) The nature of the contract given to staff be enhanced to be recognized by financial lending institutions. They proposed that the Constituency Liaison Office should come up with a pay slip system for constituency staff
 - d) The officers alleged that Kenya Revenue Authority officers insist on ETR (Electronic Tax Register) and a 2% withholding fee on every consumable item. The constituency office could not provide ETR for items such as milk bought from local farmers
 - e) There is 10% withholding on rent by landlords. The staff urged for relaxation of the regulations surrounding office space allocation in rural areas

3.5.2 Ol Kalou Constituency

- 71. The delegation visited the office of the Member of Parliament for Ol Kalou Constituency on Saturday, 2nd December, 2023 at 2:30 p.m. A team of officers led by the Constituency Office Manager received the Committee.
- 72. The Chairperson briefed the sitting on the mandate of the Committee and the rationale for the inspection visit. He then invited the Constituency office staff to brief the delegation on the staff, facilities, and challenges at the office.
- 73. The Constituency Office Manager informed Members of the following challenges:
 - a) Delay in release of funds for operations
 - b) The medical insurance provided by NHIF was not enough. They requested for enhancement of their medical cover similar to that of the civil servants and in line with their contributions
 - c) There are no seminars, workshops and training for staff at the constituency office
 - d) There is need to pay salaries directly into individual bank accounts of constituency staff instead of through office managers
 - e) Further, there is no annual salary increment despite the provision of the same in their contracts, and the rise in cost of living

3.6 MACHAKOS COUNTY

74. The Committee visited the Constituencies/County offices in Machakos County on Friday, 4th and Saturday, 5th August, 2023. The inspection visit commenced with courtesy call to the Office of the County Commissioner who apprised the Committee on the state of affairs in the region.

3.6.1 Machakos Town Constituency

- 75. The Committee visited the Office of the Member of Parliament for Machakos Town Constituency, Hon. Caleb Mutiso Mule, M.P. on Friday, 4th August, 2023 at 10.00 a.m. A team of officers led by the Constituency Office Manager, Mr. Amos Masila, received the delegation.
- 76. The Chairperson briefed the sitting on the mandate of the Committee and the rationale for the inspection visit. He then invited the constituency office staff to engage the delegation on the staff, facilities, and challenges at the office.
- 77. The Constituency Office Manager Mr. Amos Masila informed Members of the following challenges:
 - a) There were handing over challenges that led to penalties and huge pending bills on KRA, NHIF and NSSF statutory deductions
 - b) The constituency office staff registered their complaints that there were delays in processing of gratuities
 - c) The accounting practices associated with the Constituency Liaison Office were tedious, voluminous and subject to misplacement/loss of vital documents

- d) There were delays in disbursement of funds for rent and office operations
- e) High rent leases from lenders within Machakos town; the Constituency office is located in a high rental area hence should not be allocated same amount as other Constituencies
- f) The office furniture was in a dilapidated condition and lacked ICT related facilities
- g) Access to bank loans was also sighted as a challenge due to lack of job security in their current contracts.

3.6.2 Office of the County Woman Member of Parliament - Machakos County

- 78. The Committee visited the Office of the Member of Parliament for Machakos County Hon. Joyce Kamene, MP on Friday, 4th August, 2023 at 2.30 p.m. A team of officers led by the Office Manager Mrs. Elizabeth M. Maithya received the delegation.
- 79. The Chairperson briefed the sitting on the mandate of the Committee and the rationale for the inspection visit. He then invited the office staff to engage the delegation on the staff, facilities and challenges at the office.
- 80. The Office Manager Ms. Elizabeth informed Members of the following challenges:
 - a) The Operations fund is released towards the end of every quarter thus affecting Constituency office operations and activities. There is need to release the money on monthly basis for easier facilitation
 - b) The NHIF medical insurance cover was not adequate and the officers requested for enhancement of their medical cover
 - c) There are no induction programs and trainings for the Constituency office staff to enhance their skills and capacity
 - d) Access to bank loans was also sighted as a challenge due to lack of job security in their current contracts
 - e) Lack of ICT related facilities and the need to access the digital space led to delay in offering services

3.6.3 Mavoko Constituency

- 81. The Committee visited the Office of the Member of Parliament for Mavoko Constituency, Hon. Patrick Makau, M.P. on Saturday, 5th August, 2023. A team of officers led by the Constituency Office Manager Mr. Boanerges Mutuku received the delegation.
- 82. The Chairperson briefed the sitting on the mandate of the Committee and the rationale for the inspection visit. He then invited the constituency office staff to engage the delegation on the staff, facilities, and challenges at the office.
- 83. The Office Manager Mr. Boanerges Mutuku informed Members of the following challenges:
 - a) Members observed that the office location was not conducive to host a Member of Parliament and Constituency staff
 - b) There was no training for the Constituency office staff, and the staffs were not aware of their job descriptions and roles.
 - c) The Office Manager lamented that the funds for office operations was not sufficient and requested for enhancement of the same

- d) The officers lamented that NHIF medical cover provided for the Constituency staff was not commensurate to their contributions
- e) The emoluments of the staff working at the Constituency offices were not adequate to cushion the staff from the ever-escalating cost of living and to motivate them

4.0 COMMITTEE OBSERVATIONS

84. The Committee made the following observations: -

- a) The accounting system used by the Constituency Liaison Office was not automated to ensure quick and prompt feedback on disbursement of operations fund, salaries and other emoluments of the staff in the Constituency/County offices of Members.
- b) The emoluments of staff working at the Constituency offices were not enhanced and there was no annual salary increment despite provision of the same in their contracts.
- c) Staff at the Constituency offices lacked requisite training to enhance their skills and competencies in receiving and handling constituents' issues and complaints.
- d) Due to penalties imposed by the Kenya Revenue Authority, National Health Insurance Fund and National Social Security Fund arising from late submission of documents and statutory returns, a number of Constituency offices could not obtain certificates of compliance from the concerned institutions.
- e) The NHIF medical cover/facilities and services provided for Constituency staff is not commensurate to their contributions forcing them to seek for alternative medical care.
- f) The operations fund is released towards the end of every quarter thus affecting Constituency office operations and activities.
- g) The Ksh. 150,000.00 meant to cushion the constituency offices against penalties on late remittances of statutory deductions is not adequate to cover the delays in release of funds and address any eventualities.
- h) The requirement for title deeds among other documents in processing of leases and rental agreements was making it difficult to get ample office space in Constituencies situated in rural areas where land is communal.

5.0 COMMITTEE RECOMMENDATIONS

85. The Committee made the following recommendations: -

- a) The Constituency Liaison Office should automate most of its accounting systems to ensure there is quick feedback and reduce the workload. This will ensure matters such as salaries and other emoluments of the staff in the County/Constituency offices of Members are disbursed in a timely manner. This would also avoid unnecessary penalties on staff due to late remittance of statutory deductions such as NSSF and KRA.
- b) The emoluments of the staff working at the County/Constituency offices should be enhanced by the Parliamentary Service Commission (PSC) to cushion the staff from the ever-escalating cost of living and to motivate them adequately.
- c) The PSC should, through the Centre for Parliamentary Studies and Training, organize for seminars and workshops and develop a curriculum for continuous training and capacity building for all staff of the constituency offices of Members.
- d) The Constituency Liaison Office should release the funds for operations on monthly basis to constituencies to ease operations and provide necessary facilitation, as some bills are payable monthly.
- e) The PSC through the Constituency Liaison Office to negotiate with the Social Health Authority to consider enhancing the cover of the constituency and county office staff to the civil servants' level to enable staff get a cover commensurate to their needs and contribution.
- f) The PSC should review upwards the Ksh. 150,000.00 meant to cushion the offices against penalties on late remittances of statutory deductions such as NSSF and KRA.
