#### 1.0 PREFACE

The Select Committee on Constituencies Development Fund (CDF) is established under Section 28 of the Constituencies Development Fund Act, 2013. Section 28(1) of the Constituencies Development Fund Act provides that *"the National Assembly shall, in accordance with its Standing Orders, establish a Select Committee consisting of a chairperson and not more than ten other members of the National Assembly"*. However, by a resolution of the House, the Committee Membership was expanded to nineteen Members in May, 2013.

#### 1.1 Mandate of the Committee

Section 28(5) of the Constituencies Development Fund Act, 2013, expounds on the mandate of the Committee. The functions of the National Assembly Select Committee on the Constituencies Development Fund includes, among others:-

The Select Committee has executed its mandate in accordance with the provisions of the CDF Act 2013 Section 5(5) and Standing Order 216(5).

#### 1.3 Consideration of the nominees to the Constituencies Development Fund (CDF) Board

Following receipt of the nomination by Cabinet Secretary of Ministry of Devolution and Planning of Hon. Elias Mbau, Prof. Margaret Jepkirui Muthwii, Eng. Hillary James Nyaanga and Mr. Mike Iravo to serve as Board members of the Constituencies Development Fund from the Cabinet Secretary Ministry of Planning and Devolution, the Hon. Speaker of the National Assembly, on 3<sup>rd</sup> December, 2014, referred the names of the nominees to the Select Committee on Constituencies Development Fund for consideration prior to approval by the National Assembly.

Section 3 of the Public Appointments (Parliamentary Approval) Act (No.33 Of 2011), provides for the exercise of powers of appointment under the Constitution. Under the Public Appointments (Parliamentary Approval) Act and the Standing Orders, the National Assembly is required to conclude the process of approval or rejection of the nominee(s) within fourteen (14) days from the date of notification.

After receiving the names of the nominees, the Committee commenced its sittings on Tuesday 9<sup>th</sup> December, 2014. In conducting the vetting exercise, the Committee made reference to the Constitution, the Public Appointments (Parliamentary Approval) Act No. 33 of 2011, and the National Assembly Standing Orders.

The Committee complied with the Constitutional and legal requirements and established procedures for vetting. It ensured public participation and openness in carrying out the proceedings was adhered to. Advertisements inviting the public to submit memoranda were placed in the mainstream print media, in tandem with the law, on Friday 5<sup>th</sup> December, 2014.

In addition, notifications were placed in the print media to inform the public of the time and place for holding an approval hearing at least seven (7) days prior to the hearing, in accordance with Section 6(4) of the Public Appointments (Parliamentary Approval) Act, 2011. The notifications were also carried in the mainstream print media on Friday, 5<sup>th</sup> December, 2014.

The Committee did not receive any memoranda from the public by the deadline, despite having requested the public to submit such memoranda, in accordance with Section 6(9) of the Public Appointments (Parliamentary Approval) Act, 2011.

#### 2.0 BACKGROUND

2.1 Establishment of the Constituency Development Fund

Section 4 of the CDF Act provides for the establishment of the Fund.

- 4. Establishment of the Fund
  - (1) There is established a Fund to be known as the Constituencies Development Fund which shall:-

- (a) be a national fund consisting of moneys of an amount of not less than 2.5% (two and half per centum) of all the national government ordinary revenue collected in every financial year;
- (b) comprise of any moneys accruing to or received by the Board from any other source;
- (c) disbursement by the national government through the Board to constituencies as a grant to be channeled to constituencies in the manner provided for by this Act;
- (d) be administered by the Board.
- (2) The Fund established under this section shall be the successor to the Constituencies Development Fund established by section 4 of the Constituencies Development Act, 2003.
- 5. Establishment of the Board
  - (1) There is established a Board to be known as the Constituencies Development Fund Board.
  - (2) The Fund shall be administered by a Board of Directors which shall consist of-
    - (a) the Principal Secretary in the State Department relating to economic planning or a designated alternate, not being below the level of Director of Planning;
    - (b) the Principal Secretary in the State Department for the time being responsible for matters relating to finance or a designated alternate not being below the level of Deputy Director of Budget;

On 5<sup>th</sup> December, 2014, the Committee, through the Clerk of the National Assembly, placed notifications in the print media informing the general public of the intention of the National Assembly to conduct approval hearings, as provided for by Article 118(1) and (2) of the Constitution, Standing Order 198 (1) and Section 6(5) and (6) of the Public Appointments (Parliamentary Approval) Act, 2011, which allow public participation in Committee proceedings.

The Clerk of the National Assembly gave provision for the submission of memoranda to his office, on the suitability or otherwise of the nominee, by Wednesday 10<sup>th</sup> November 2014, at 5.30 pm.

2.7 Statutory requirements

On 5<sup>th</sup> December 2014, the Clerk of the National Assembly wrote to the Kenya Revenue Authority (KRA) and the Higher Education Loans Board (HELB) requesting information on whether the nominees were tax compliant and whether they owed any loans to the Board, respectively. The Clerk also wrote to the Ethics and Anti-Corruption Commission (EACC) seeking information on the integrity of the nominees.

#### 2.8 Notification to the nominees

On 5<sup>th</sup> December 2014, the Clerk of the National Assembly, pursuant to Section 6(3) of the Public Appointments (Parliamentary Approval) Act (No. 33 of 2011), notified the nominees of the time and place for holding the approval hearings.

#### 2.9 Committee meetings

The Committee commenced the vetting process on Tuesday, 9<sup>th</sup> December 2014. A total of six Sittings were held. The Committee's first business was to formulate questions on the vetting in line with the Public Appointments (Parliamentary Approval) Act No.33 2011, and examine memoranda so far received. The second Sitting of the Committee was held on Thursday, December 11, 2014 to vet nominees. The Committee also held four more Sittings during which the draft report on the vetting of the nominees was considered and adopted.

#### 2.10 Submission of memoranda

By close of business on Wednesday 10<sup>th</sup> December 2014, the Committee had not received any memoranda in support or against the nomination of the four persons.

#### 2.11 Clearance letters

Further, the Committee received a letter from the Higher Education Loans Board, stating that the nominees did not owe the Board any unpaid loans. The Committee was also in possession of copies of tax certificates from the Kenya Revenue Authority, confirming that all nominees were tax compliant.

The Ethics and Anti-Corruption Commission wrote back to the Committee, indicating that the proposed nominees did not have integrity issues that the Commission was aware of.

#### 2.12 The Vetting Process

On Thursday 11<sup>th</sup> December 2014, the Committee commenced the vetting exercise. In conducting the vetting exercise, the Committee was guided by, among other documents, the Constitution of Kenya, the Public Appointments (Parliamentary Approval) Act No. 33 of 2011 and the National Assembly Standing Orders.

#### 3.0 VETTING OF NOMINEES

The Select Committee on the Constituencies Development Fund examined the nominees using the guidelines provided for in the Public Appointments (Parliamentary Approval) Act No. 33 of 2011. The Committee also considered the following criteria in vetting the nominees:-

- (i) Academic qualifications;
- (ii) Employment record and work experience;
- (iii) Professional association;
- (iv) Public office, political activities and affiliations;
- (v) Potential conflict of interest;
- (vi) Suitability & Capacity to the position; \_\_\_\_
- (vii) Tax compliance; and
- (viii) Integrity.

#### 3.1 HON. ELIAS MBAU

#### Personal Background

 Hon. Elias Mbau appeared before the Committee on Thursday 11<sup>th</sup> December, 2014 and informed the Members that he is 53 years old. He is married with three children.

#### Educational Background

 He holds a Masters degree in Business Administration (MBA) and a Bachelor of Arts (B.A.) (Hons.) in Economics from the University of Nairobi. He is a registered member of the Certified Public Secretaries of Kenya. Further, he is pursuing a Doctor of Philosophy degree from the University of Nairobi.

#### Working Experience

- He has four years' experience working as a public servant. He served as a Member of Parliament between 2002 and 2012.
- During his term in Parliament, he was Chairman of the Budget Committee which incorporated Chairpersons of all other Departmental Committees as exofficio members.
- He co-chaired the Committee which was deliberating on Chapter 12 of the constitution on Public Finance during the 'Bomas' process that produced the initial draft of the current Constitution.
- He served as a member of the steering committee of the African Parliamentary Strengthening Program (APSP) whose headquarters are at the Parliamentary Centre, Ghana.
- He Co-chaired the final engagements with Treasury during the processing and enactment of the Public Finance Management Act (PFM), of 2012.
- He served as a member of the Speakers Roundtable Forum whose key
  objective was to provide a forum for regular engagement with the private sector under the auspices of the Kenya Private Sector Alliance (KEPSA) on various issues.

#### Personal achievements

• He successfully navigated the all-important Fiscal Management Bill into an Act whose cardinal objective was to incorporate Parliament in the Budget Making Process of the Republic of Kenya.

- He spearheaded the anchoring of the contents of the PFM Act into the Constitution through Article 221 as well as in the Standing Orders of the National Assembly. He participated in marshalling and building consensus on the all-important issues of resource allocation during the budget processing and approval, particularly during the transitional period.
- He received and engaged in instructive discussions with delegations and missions intent on Public Finance and Budget issues from many countries and organizations including Germany, South Africa, Ghana, among others.
- As chairman of the Budget Committee, he successfully recommended for the separation of the former Office of the Controller and Auditor General into those of the Auditor General and Controller of Budget, now anchored in the Constitution.
- He successfully and under very difficult transitional circumstances persuaded the Government to comply with the Constitution and other statutes in the dramatic changes required in processing the national budget, its associated policy documents as well as the Appropriation Bills.
- Over the ten year period as MP for Maragua, he was able to prudently harness and utilize both public and private resources so as to uplift the standards of those living below the poverty line from a low of 45% in 2004, to 29% in 2008 which was the last recorded data by Kenya National Bureau of Statistics.

He holds a Doctorate of Philosophy degree in Human Resource Management from Jomo Kenyatta University of Agriculture and Technology (JKUAT), a Masters degree in Administration and Planning from the University of Nairobi, a Diploma in Personnel Management and Industrial Relations and Diploma of Principles of Modern Management from the College of Professional Management, Jersey, London (UK), a Post Graduate Diploma in Education from Kenyatta University and a Bachelors of Arts degree in Theology from Sibiu University, Romania.

#### 3.2.3 Working Experience

- He is currently a full time employee of JKUAT serving as a Director/Principal at the University's Town Campus in Westlands.
- He served as Chairman, Department of Entrepreneurship and Procurement between 2009 and 2013.
- He serves as a Senior Lecturer (Management, Governance and Leadership) from 2006 to date.

#### 3.2.4 Personal achievements

- As the Chairman, Department of Entrepreneurship and Procurement between 2009 and 2013, Dr. Mike Iravo achieved the following, he:-
- Participated in structuring the Department. The immediate impact was harmony, efficiency and effectiveness, increased student enrolment from 286 to 2,354, increase of programs from 1 to 9 and rise of academic staff from 11 to 45.

• He is currently working in the Ministry Transport and Infrastructure as a Senior Principal Superintendent Engineer.

#### 3.3.4 Personal Achievements

• He was involved in overseeing the construction to completion of the Technical workshop at 78 Tank Battallion in Isiolo.

- He chaired a task force which produced the final draft of the Public Works Policy for the Ministry.

- She is currently the Vice Chancellor of the Pan Africa Christian University (PACU), having been appointed in January 2014. She has undertaken a top leadership role at the university in terms of its finance, administration and academic/research functions. She also spends time and energy in guiding its income generating functions.
- She has served as a Translation Consultant with the United Bible Societies from January 2001 to December 2013 at the Bible Translation Centre of the Bible Society of Kenya. She led the translation projects in Gikuyu, Kalenjin, Kikamba, Kimeru, Kiembu-Kimbeere, Oluluyia, Lukakamega/Lutirichi and Lulogooli Bibles among others.
- She served as a Deputy Registrar (Academic) at Kenyatta University between 1998 and 2001. She also served in several teaching positions at Kenyatta University between 1987 and 1997.

- (i) He served in the public service for four years. He is also well versed in matters pertaining to budget making procedures and finance.

- (iii) The Committee agreed that the nominee was qualified for the post and would articulate his leadership and expertise in financial matters if appointed as a CDF Board member. It was also noted that he is not in full time employment.

(iv) The nominee is qualified for appointment as a CDF Board member.



Have led delegations of Members of Parliament and staff to various study tours and workshops on issues of public finance, budgetary oversight, devolution and governance in countries such as Uganda, Ghana, Phillipines, Germany, Zambia, the states of Maryland, Massachusets and Washington DC.

- Have also been a member of the steering committee of African Parliamentary Strengthening Program (APSP)\* headquartered at Parliamentary Centre Ghana. The object of the programme is capacity building to members of parliament and staff involved in Budget Oversight for the seven partner countries of Ghana, Zambia, Tanzania, Kenya, Uganda, Benin and Senegal. The programme, with support by CIDA aims to implement strategies that strengthen the role of Members of Parliament in their engagement in the National budget process, oversight and audit.
- Have had the honour and privilege to receive and engage in instructive discussions with delegations and missions intent on Public Finance and Budget issues from many countries and organizations including Germany, South Africa, Ghana inter alia.
- Have always had to meet and hold discussions with the IMF and World Bank foreign teams every time they have had a Review of the economy and its budgetary support needs. These are crucial sessions where donor agencies wish to secure either the views or support of Parliament before they can make their final recommendations to their respective Boards; to either extend or hold onto their credit facilities.
- Co-chaired the final engagements with Treasury in the marathon processing and enactment of the Public Finance Management Act (PFM), 2012.

As chairman of Budget Committee, we successfully recommended for the separation of the former office of Controller and Auditor General into those of Auditor General and Controller of Budget, now anchored in the constitution.

APSP- The annual stakeholder meeting for the African Programme on the Budget Oversight is scheduled for 24<sup>th</sup> -25<sup>th</sup> May, 2014 in Lusaka, Zambia.

Have successfully and under very difficult transitional circumstances compelled the Government to comply with the constitution and other statutes in the dramatic changes required in processing the national budget, its associated policy documents as well as the appropriation bills.

- Have had a chance to work very harmoniously and effectively with many government departments and agencies but more specifically those that have fallen under the purview of Budget Committee viz:
  - Commission on Revenue Allocation.
  - Kenya Revenue Authority.
  - The Treasury.
    Auditor-General.

- I have been a member of the Speakers Roundtable Forum whose key objective is providing a forum for regular engagement with the private sector under the auspices of **KEPSA** on various issues.

- Having had the honour and privilege to have served the Kenyan public in various positions enumerated above and lately as a legislator, I feel particularly and passionately inclined to continue serving my country on a consultancy basis in various fields that are relevant to my knowledge, expertise and experience.
- I'm ever eager to be given a chance to continue rendering my service during this crucial transitional period, which requires diligence in implementing the constitution and accruing subsidiary legislations in order for Kenyans to begin to derive the enormous benefits of the constitution in the shortest time possible.

The interaction with the agency and information/arguments won the day and that year we got funding for special projects amounting to \$ 160,400.
- b) The Rockefeller Foundation Research Award (2002) got research grant of over \$400,000 to undertake a major twenty-four-month literacy research whose focus was the establishment of English language norms for Kenyan primary schools. (Similar studies ran concurrently in Uganda and Zimbabwe.) In its second year, I had to discontinue active involvement in this research due to a prolonged relocation from Nairobi to Amsterdam.
- c) The Rockefeller Foundation Research Award (Sept. -Nov. 2000) got research grant of \$20,000 to undertake research on the nature of the language policy for primary schools in Kenya and the actual implementation of such policy. Project title: "Language Policy and Practices in Education: Perceptions of Parents, Pupils, and Teachers on the Language of Instruction among the Kalenjin in Bomet and Nakuru Districts". The results of this research are reported in Muthwii 2002.
