## **1.0 PREFACE**

### **Hon Speaker,**

I wish to table the Report of the Departmental Committee on Defence and Foreign Relation on the Vetting of Major General (Rtd) Lucas K. Tumbo for Appointment to the Position of Ambassador to Federal Republic of Somalia and commend it to the House for adoption.

### **1.1 Committee Mandate**

#### **Hon. Speaker,**

The Departmental Committee on Defence and Foreign Relations is established pursuant to Standing Order 216 (1) and mandated to: –

- i. Investigate, inquire into and report on all matters relating to the mandate, management, activities, administration, operations and estimates of the assigned Ministries and Departments;*
- ii. Study the programme and policy objectives of the Ministries and Departments and the effectiveness of the implementation;*
- iii. Study and review all legislation referred to it;*
- iv. Study, assess and analyse the relative success of the Ministries and Departments as measured by the results obtained as compared with its stated objectives;*
- v. Investigate and inquire into all matters relating to the assigned Ministries and Departments as they may deem necessary, and as may be referred to them by the House;*
- vi. To vet and report on all appointments where the constitution or any law requires the national assembly to approve, except those under Standing order 204 (committee on appointments); and*
- vii. Make reports and recommendations to the House as often as possible, including recommendations of proposed legislation.*

#### **Hon. Speaker,**

In executing its mandate, the Committee oversees the following Ministries, independent government agencies and state Department:

- i. Ministry of Defence;*
- ii. Ministry of Foreign Affairs;*
- iii. East African Affairs; and,*

### **1.3 Appointment of Ambassadors**

#### **Hon. Speaker,**

Article 132 (2)(e) of the Constitution provides that, H.E. the President shall nominate and with the approval of the National Assembly, appoint High Commissioners, Ambassadors, Diplomatic and Consular Representatives.

The duties of High Commissioners and Ambassadors include, among others:-

- (i) Advancement and protection of Kenya's interests in the host Countries and Countries of accreditation through innovative Diplomacy;
- (ii) Promotion of Kenya's influence in international decision making;
- (iii) Protection of Kenya's sovereignty and territorial integrity;
- (iv) Promotion and strengthening of bilateral/multilateral cooperation/ties;
- (v) Promotion of sub-regional, regional and international integration and cooperation; and
- (vi) Promotion of public Diplomacy.

On the 3<sup>rd</sup> March 2015 the Speaker, conveyed to the House a message from H. E. the President done through a letter dated 23<sup>rd</sup> February, 2015. In the letter, H. E. the President had nominated Major General (Rtd) Lucas K. Tumbo for the position of Ambassador to the Federal Republic of Somalia for approval by the House pursuant to Article 132(2) (e) of the Constitution of Kenya.

Subsequently, the Speaker referred the Message from H. E. the President containing the name of the nominee together with his curriculum vitae to the Departmental Committee on Defence and Foreign Relations to conduct the vetting and table its report.

### **1.4 Vetting of the nominee for the position of Ambassador to the Federal Republic of Somalia**

#### **Hon. Speaker,**

The Committee placed adverts in the mainstream print media, on Wednesday, 4<sup>th</sup> March 2015, inviting the public to submit memoranda and notifying the public of the vetting exercise in accordance with the law. The Committee, in compliance with the Article 118 of the Constitution, other legal requirements and established procedures for vetting, ensured its meetings were open to the public and covered by the media.

In conducting the vetting exercise, the Committee made reference to the Constitution, the Public Appointments (Parliamentary Approval) Act, 2011, and the Standing Orders. During

the approval hearing, the Nominee made submissions on his suitability for appointment to the position of the Ambassador to Federal Republic of Somalia.

The Committee deliberated on the nominee's bio-data, curriculum vitae, written and oral submissions during the vetting exercise at the Sitting held on Thursday, 12<sup>th</sup> March, 2015 and came up with several findings.

The observations, findings and conclusions guided the Committee in making its final recommendations which were unanimously adopted during a report-writing retreat held from 13<sup>th</sup> to 14<sup>th</sup> March, 2015 at the Boma Hotel, Nairobi.

The Committee after the vetting exercise found the nominee suitable for appointment as Kenya's Ambassador to the Federal Republic of Somalia.


### **1.5 Acknowledgment**

## **2.0 BACKGROUND**

### **2.1 Establishment of the Office of High Commissioners/Ambassadors**

The Office of Ambassadors is an Office under the Ministry of Foreign Affairs and International Trade. The duties of High Commissioners and Ambassadors include, among others:-

- (i) Advancement and protection of Kenya's interests in host Countries and Countries of accreditation through innovative Diplomacy;
- (ii) Promotion of Kenya's influence in international decision making;
- (iii) Protection of Kenya's sovereignty and territorial integrity;
- (iv) Promotion and strengthening of bilateral/multilateral cooperation/ties;
- (v) Promotion of sub-regional, regional and international integration and cooperation; and
- (vi) Promotion of public Diplomacy, among other duties.

### **2.2 Nomination of High Commissioners/Ambassadors**

Article 132(2) (e) of the Constitution provides that:-

***"The President shall nominate and, with the approval of the National Assembly, appoint and may dismiss- ... (e) High Commissioners, Ambassador and Diplomatic and Consular Representatives"***

### **2.3 Issues for consideration in conducting the Approval hearing**

In conducting the approval hearing, the Committee was guided by Article 73 (2) of the Constitution and the provisions of Sections 6 (7) (8) and 7 of the Public Appointments (Parliamentary Approval) Act, 2011.

Article 73(2) of the Constitution provides that: -

The guiding principles of Leadership and Integrity include:-

- (a) Selection on the basis of personal integrity, competence and suitability, or election in free and fair elections;
- (b) Objectivity and impartiality in decision making, and in ensuring that decisions are not influenced by nepotism, favoritism, other improper motives or corrupt practices;
- (c) Selfless service based solely on the public interest, demonstrated by-
  - (i) Honesty in the execution of public duties; and,
  - (ii) The declaration of any personal interest that may conflict with public duties;
- (d) Accountability to the public for decisions and actions; and
- (e) Discipline and commitment in service to the people.

## **2.4 Message from H.E. the President**

On 3rd March 2015 the Speaker pursuant to Standing Order 42, conveyed to the House a message from H.E. the President. By way of a letter dated 23<sup>rd</sup> February 2015, the president had nominated Major General (Rtd) Lucas K. Tumbo as Ambassador to the Federal Republic of Somalia for approval by the House pursuant to Article 132 (2) (e) of the Constitution:-

Article 132(2) (e) of the Constitution confers upon the President the power to nominate, and subject to approval by the National Assembly, appoint Ambassadors and High Commissioners.

Subsequent to the conveyance of the Message from H.E. the President on the nomination, the Speaker of the National Assembly forwarded the name of the Nominee together with his curriculum vitae to the Departmental Committee on Defence and Foreign Relations to conduct approval hearings.

## **3.0 REQUIREMENTS OF THE VETTING PROCESS**

### **3.1 Clearance Requirements**

On the 4<sup>th</sup> of March 2015, the Clerk of the National Assembly wrote to the Ethics and Anti-Corruption Commission seeking information on the integrity of the Nominee. Two other letters were written to the Kenya Revenue Authority (KRA) and the Higher Education Loans Board (HELB) requesting for information on whether the Nominee was tax compliant and whether he owed any loans respectively. The Clerk also wrote to the Criminal Investigations Department seeking information on the conduct of the nominee. The Nominee was also required to present his clearance/compliance certificates and letters from the above institutions as well as from any of the Credit Reference Bureaus.

### **3.2 Notification to the Nominee**

On 4<sup>th</sup> of March 2015, the Clerk of the National Assembly, pursuant to Section 6(3) of the Public Appointments (Parliamentary Approval) Act, 2011, notified the Nominee of the time and place for holding the approval hearings.

### **3.3 Notification to the Public**

Section 6(9) of the Public Appointments (Parliamentary Approval) Act No. 33 of 2011, provides that *“any person may, prior to the approval hearing, and by written statement on oath, provide the Clerk with evidence contesting the suitability of a candidate to hold the office to which the candidate has been nominated”*.

On 4<sup>th</sup> March 2015, the Committee, through the Clerk, placed notifications in the print media informing the general public of the intention of the National Assembly to conduct approval hearings of the Nominee and requesting Memoranda on the suitability or



otherwise of the nominee, pursuant to **Article 118 (1) (a) (b) and (2)** of the Constitution, **Standing Order 198 (1) and Section 6(4)** of the Public Appointments (Parliamentary Approval) Act, 2011, which allow public participation in Committee proceedings. The Clerk of the National Assembly gave notification to the public to submit memoranda to his office, on the suitability or otherwise of the Nominee, by Monday, **10<sup>th</sup> March, 2015**.

### **3.4 Committee Meetings**

The Committee carried out the vetting exercise on Thursday 12<sup>th</sup> March, 2015. A total of five (5) Sittings were held in relation to the vetting exercise. The Committee's first business was to formulate questions on the vetting exercise in line with the Public Appointments (Parliamentary Approval) Act, 2011, and examine Memoranda thus far received.

### **3.5 Submission of Memoranda**

As at the time of the vetting exercise, the Committee had not received any memoranda from members on the suitability or otherwise of the Nominee as provided for in Section 6 (9) of the Public Appointments (Parliamentary Approval) Act, 2011.

The Committee received letters from the Kenya Revenue Authority, indicating that the Nominee was tax compliant, and the Higher Education Loans Board, stating that the Board was not owed any loans by the Nominee.

A letter from the Ethics and Anti-Corruption Commission confirmed that it did not have any outstanding matters or ongoing investigations against the Nominee.

The Nominee also presented before the Committee his Certificate of Good Conduct and Clearance from the Credit Reference Bureau.

## **4.0 VETTING OF NOMINEE FOR APPOINTMENT TO THE POSITION OF AMBASSADOR TO THE FEDERAL REPUBLIC OF SOMALIA**

On Thursday, 12<sup>th</sup> March 2015, the Committee held a vetting session with the nominee for the position of Ambassador to the Federal Republic of Somalia. In conducting the vetting exercise, the Committee was guided by, among other documents, the Constitution, the Public Appointments (Parliamentary Approval) Act, 2011 and the National Assembly Standing Orders.

The Committee examined the Nominee using the guidelines provided for in the Public Appointments (Parliamentary Approval) Act, 2011. The Committee also followed the following criteria in vetting the Nominee: -

- (i) Academic qualifications
- (ii) Employment record and work experience
- (iii) Professional association

- (iv) Public office, political activities and affiliations
- (v) Potential conflict of interest
- (vi) Suitability to the position
- (vii) Tax compliance
- (viii) Integrity

Major General (Rtd) Lucas Tumbo appeared before the Committee on Thursday, 12<sup>th</sup> March 2015, at 10.00am. The Committee having heard his submissions during the meeting, made the following observations on his nomination for appointment to the position of **Kenya's Ambassador to Federal Republic of Somalia:-**

### **(i) Personal Background**

He was born on 20<sup>th</sup> April 1957 in Kitui County.

### **(ii) Academic Background**

- Certificate of Commendation - Special Representative of the UN Secretary General in the United Nations Mission in Ethiopia and Eritrea (**UNMEE**).

- Force Commander's Commendation - Force Commander of the United Nations Mission in Ethiopia and Eritrea (**UNMEE**).
- Force Commander's Commendation - Force Commander of the United Nations Mission in Sudan (**UNMIS**).

## **5.0 EMERGING ISSUES ARISING FROM THE VETTING PROCESS**

The following issues were raised with the nominee by the Committee during the vetting process:-

### **1. Withdrawal of the KDF from Somalia**

The nominee observed that Kenya Defence Forces (KDF) had gone into Somalia under *Operation Linda Nchi*, and the operation had since ended. Currently KDF is in Somalia under the mandate of the African Mission in Somalia (AMISOM), therefore the decision to withdraw would have to be in line with the resolutions of the Africa Union (AU).

### **2. Militarization of the Public Service**

On the perceived militarization of the civilian government, with many former military officers being appointed into the public service, including him, the nominee noted that like other Kenyans, former military officers had the capacity to serve as public servants. Further, he pointed out that military officers are trained extensively using public resources but retire early due to the nature of their job. Hence there is need to utilize their knowledge and experience through other avenues.

### **3. Illegal trade**

The lack of regulations governing most trade along the Kenya- Somali border led to other vices such as the proliferation of small arms and light weapons, influx of contraband goods and the consequent loss of revenue because tax is not collected by either country. The nominee noted that fostering good relations with the leadership of Somalia would greatly aid in stopping this vice.

The nominee promised to engage Somali authorities on the ways of limiting the proliferation of small arms and light weapons.

### **4. Terrorism**

The Nominee assured the Committee that he would strengthen ties between the Kenya Government and Somali Government to enforce all counter-terrorism measures.

## **5. Reconstruction of Somalia**

The nominee informed the Committee that he would work towards strengthening Kenya – Somali cooperation in order to ensure that Kenya played an active and significant role in the reconstruction of Somalia's infrastructure (Kenya would be a close source of raw materials), industries and economy as a whole.

## **6. Capacity building of the people of Somalia**

The Nominee pointed out that it would be considerably cheaper for Somali nationals to be trained in Kenya instead of abroad like in the United Kingdom (UK). He promised to work towards strengthening Kenya – Somali relations in the area of skills exchange as Kenya possess vast amounts of skilled labor in all areas of industry with a view to building mutual social and economic benefits.

## **7. Dispute between Kenya and Somalia at the International stage**

The nominee informed the committee that he was aware of the case by Somalia against Kenya at the International Court of Justice (ICJ) on the maritime boundaries, and the Petition against Kenya at the US Senate by Somalis in the Diaspora on the maritime dispute and the presence of KDF in Somalia. However, he noted that this would not hinder the use of diplomacy as he interacts with the Somali people.

## **8. Authenticity of academic degrees and the recognition of the University**

The Nominee stated that he obtained his qualifications from educational institutions that enjoy international recognition.

## **9. Challenges likely be to encountered while settling in Somalia**

The nominee pointed out that other countries such as Sudan, Uganda, Qatar and Ethiopia already had embassies in Somalia. He would adhere to the security measures that they had already adopted to ensure his safety while in Somalia.

## **10. Status of Somali Refugees in Kenya**

The Nominee acknowledged that the number of refugees had increased in recent years due to instability in Somalia and that there was need for other countries both regional and international, to join hands to help stabilize Somalia. Stability would lead to prosperity in Somalia which would in turn solve the Somali refugee issue for Kenya.

## **11. Views on Federal States**

While admitting that the National Constitution lays out the basic way in which the Government is to operate, the nominee also noted that internal politics contributed a lot. He added that deliberations between Somali federal and regional politicians should come into effect, only if the Constitution will be ratified by the new Parliament.

## **12. Peace Keeping Experience**

The nominee informed the Committee that he would use the lessons he had learnt during peace keeping missions in Namibia, Eritrea and Ethiopia, to handle the situation in Somalia. He would endeavor to work with the government of the Republic of Somalia and also use diplomatic channels in his work as Kenya's Ambassador to the Republic of Somalia, subject to Parliament's approval of his appointment.

## **6.0 COMMITTEE OBSERVATIONS**

The Committee having considered the curriculum vitae of the Nominee, and having heard his oral submissions during the vetting exercise, at the Sitting held on Thursday, 12<sup>th</sup> March, 2015, made the following observations:-

- (i) The Nominee had the requisite abilities, qualifications and experience, which qualify him for appointment as Kenyan Ambassador to the Federal Republic of Somalia. His suitability was enhanced by the fact that he was tax compliant, he did not have any loan arrears with the Higher Education Loans Board and neither did he have any credits as he was cleared by the Credit Reference Bureau. Further, the nominee was cleared by the Ethics and Anti-Corruption Commission (EACC) which fulfills the requirement of integrity as set out in the Public Appointments (Parliamentary Approval) Act, 2011.
- (ii) The Nominee exhibited impressive knowledge of topical issues touching on among others, Kenya's Foreign Policy and Diplomacy, which are basic requirements for Kenya's diplomatic representative. He exhibited knowledge on transitioning countries having worked in Ethiopia, Eritrea, Somalia and Djibouti. He understands fully the importance of collaboration between governments.
- (iii) The nominee was keen on making positive proposals on how to advance Kenya's Foreign Policy in Somalia, and strengthen the Kenya-Somalia relationships.
- (iv) The nominee had a wide military experience in the area of conflict resolution from his extensive service in conflict situations around the world. He is well rounded beyond his military background with knowledge extending to general economics and understands Kenya's economic interest at large. He understands the effects of contraband commodities on the Kenyan economy and has good ideas on how to curb the illegal practice.

## **7.0 COMMITTEE RECOMMENDATION**

The Committee therefore finds the Nominee suitable for appointment to the position of Kenya's Ambassador to Federal Republic of Somalia and recommends that:-

**The National Assembly approves his nomination for appointment as Kenya's Ambassador to Federal Republic of Somalia**

The meeting was called to order at Ten Minutes Past Ten O'clock and prayers were said by the Hon Col. (Rtd) Ali Dido Rasso.

The Chairperson informed members that the proceedings were as a result of the President nominating Major General (Rtd) Lukas Tumbo to the position of Ambassador to Somalia, a communication which had since been made to the National Assembly and thereafter committed to the Committee on Defence and Foreign Relations.

The Chairperson briefed Members on the legal provisions on approval hearings as provided for in the Public Appointments (Parliamentary Approval) Act, 2011.

He then informed Members that since receipt of the message from the President, the Clerk of the National Assembly had invited the public to make presentations on the suitability or otherwise of the nominee to hold the office of Ambassador to Somalia, the Committee had not received any memoranda from members of the public in reference to the Nominee as

provided for in Section 6 (9) of the Public Appointments (Parliamentary Approval) Act, 2011.

The Chairperson then invited the Members of the Committee to introduce themselves. Pursuant to the provisions of Standing Order 90 (1), Hon Col. (Rtd) Ali Dido Rasso, M.P. and Hon. Elisha Busienei, M.P. declared their interest regarding the nominee.

**MIN.NO. 390/2015: VETTING OF THE AMBASSADOR NOMINEE FOR THE REPUBLIC OF SOMALIA - MAJOR GENERAL LUKAS K TUMBO**

The Chairperson congratulated the nominee and invited the nominee to take the Committee through his academic and professional qualifications, with emphasis on his suitability for the position.

### **Clearance Letters for the Nominee**

The Committee received letters from the Kenya Revenue Authority, indicating that the Nominee was tax compliant, and the Higher Education Loans Board, stating that the Board was not owed any loans by the Ambassador Nominee.

A letter from the Ethics and Anti-Corruption Commission confirmed that it did not have any outstanding matters or ongoing investigations against the Nominee.

The Nominee also presented before the Committee his Certificate of Good Conduct and Clearance letters from Credit Bureaus.

On various issues raised during the vetting process, the Nominee informed the Committee as follows:

#### **1. Withdrawal of the KDF from Somalia**

The nominee observed that Kenya Defence Forces (KDF) had gone into Somalia under *Operation Linda Nchi*, and the operation had since ended. Currently KDF is in Somalia under the mandate of the African Mission in Somalia (AMISOM), therefore the decision to withdraw would have to be in line with the resolutions of the Africa Union (AU).

#### **2. Militarization of the Public Service**

On the perceived militarization of the civilian government, with many former military officers being appointed into the public service, including him, the nominee noted that like other Kenyans, former military officers had the capacity to serve as public servants. Further, he pointed out that military officers are trained extensively using public resources but retire early due to the nature of their job. Hence there is need to utilize their knowledge and experience through other avenues.

#### **3. Illegal trade**

The lack of regulations governing most trade along the Kenya- Somali border led to other vices such as the proliferation of small arms and light weapons, influx of contraband goods

and the consequent loss of revenue because tax is not collected by either country. The nominee noted that fostering good relations with the leadership of Somalia would greatly aid in stopping this vice.

The nominee promised to engage Somali authorities on the ways of limiting the proliferation of small arms and light weapons.

#### **4. Terrorism**

The Nominee would strengthen ties between the Kenya Government and Somali Government to enforce all counter-terrorism measures.

#### **5. Reconstruction of Somalia**

The nominee would work towards strengthening Kenya – Somali cooperation in order to ensure that Kenya played an active and significant role in the reconstruction of Somalia's infrastructure (Kenya would be a close source of raw materials), industries and economy as a whole.

#### **6. Capacity building of the people of Somalia**

The Nominee pointed out that it would be considerably cheaper for Somali nationals to be trained in Kenya instead of abroad like in the United Kingdom (UK). He promised to work towards strengthening Kenya –Somali relations in the area of skills exchange as Kenya possesses vast amounts of skilled labor in all areas of industry with a view to building mutual social and economic benefits.

#### **7. Dispute between Kenya and Somalia at the International stage**

The nominee was aware of the case by Somalia against Kenya at the International Court of Justice (ICJ) on the maritime boundaries, and the Petition against Kenya at the US Senate by Somalis in the Diaspora on the maritime dispute and the presence of KDF in Somalia. However, he noted that this would not hinder the use of diplomacy as he interacts with the Somali people.

#### **8. Authenticity of academicdegrees and the recognition of the University**

The Nominee stated that he obtained his qualifications from educational institutions that enjoy international recognition.

#### **9. Challenges likely be to encountered while settling in Somalia**

The nominee pointed out that other countries such as Sudan, Uganda, Qatar and Ethiopia already had embassies in Somalia. He would adhere to the security measures that they had already adopted to ensure his safety while in Somalia.

#### **10. Status of Somali Refugees in Kenya**

He acknowledged that the number of refugees had increased in recent years due to instability in Somalia and that there was need for other countries both regional and international, to join hands to help stabilize Somalia. Stability would lead to prosperity in Somalia which would in turn solve the Somali refugee issue for Kenya.

#### **11. Views on Federal States**

While admitting that the National Constitution lays out the basic way in which the Government is to operate, he also noted that internal politics contributed a lot. He added that deliberations between Somali Federal and regional politicians should come into effect, only if the Constitution will be ratified by the new Parliament.

#### **12. Peace Keeping Experience**

The nominee informed the Committee that he would use the lessons he had learnt during peace keeping missions in Namibia, Eritrea and Ethiopia, to handle the situation in Somalia. He would endeavor to work with the Government of the Republic of Somalia and also use diplomatic channels in his work as Kenya's Ambassador to the Republic of Somalia, subject to Parliament's approval of his appointment.



Honourable Members, Article 132 (2) (e) of the Constitution of Kenya 2010 provides that-


