EXECUTIVE SUMMARY

The County Boundaries Bill, 2017 (Senate Bills No. 6 of 2017) was read a First Time on 30th November, 2017. This is a Bill for an Act of Parliament to provide for county boundaries; to provide for a mechanism for the resolution of county boundary disputes; to give effect to Article 188 of the Constitution by providing for the procedure for alteration of county boundaries; to provide for the establishment of an independent county boundaries commission; and for connected purposes

Following the First Reading of the Bill, it stood committed to the Committee on Devolution and Intergovernmental Relations (in accordance with Standing Order 134) for facilitation of public participation. Subsequently, the Committee, pursuant to Article 118 of the Constitution and Standing Order 134 (5), invited submissions from members of the public via an advertisement on the Daily Nation Newspaper on Tuesday, 27th February, 2018. The Committee received both oral and written submissions on the Bills during its meeting with the members of public held on 13th March, 2018 at the First Floor office, Red Cross Building, Parliament Buildings.

1. INTRODUCTION

1.1. The County Boundaries Bill, 2017 (Senate Bills No. 6 of 2017)

The County Boundaries Bill, 2017 is a Bill sponsored by Senator Mutula Kilonzo Junior, MP. The principal purpose of the Bill is to —

- (a) define the boundaries of the counties in Kenya;
- (b) provide for the resolution of county boundary disputes through the establishment of *ad hoc* county boundaries mediation committees; and
- (c) give effect to Article 188 of the Constitution on the alteration of county boundaries.

There is presently no mechanism for alteration of county boundaries despite the fact that Article 188 of the Constitution gives Parliament the mandate to alter the boundaries. The Bill therefore provides for the mechanism for such alteration. It also ensures that a high threshold will have to be met by any party desiring to alter the boundaries of any given county. Further, the Bill proposes a mechanism for resolution of boundary disputes through mediation.

The Bill will cure the current scenario where the boundaries of the districts in the Districts and Provinces Act are deemed to be the boundaries of the corresponding counties. Further, the Bill will enable the resolution of boundary disputes between counties through a mediation process.

The Bill will also give effect to Article 188 of the Constitution by providing a mechanism for alteration of county boundaries. It will also ensure that a high threshold is met before the boundaries of any county are altered.

2. OVERVIEW OF THE BILL

2.1. The County Boundaries Bill, 2017

(1) County boundaries

Part II of the Bill, as read with the First Schedule to the Bill, sets out the boundaries of the counties.

The Bill defines the boundaries of the forty-seven counties of Kenya by bringing into its First Schedule, the boundaries of Nairobi Area and the other forty-six Districts set out in the Districts and Provinces Act of 1992. This will render the Districts and Provinces Act obsolete, hence the repeal of the Districts and Provinces Act in clause 49 of the Bill.

(2) Resolution of county boundary disputes

Part III of the Bill provides a mechanism for resolution of county boundary disputes through *ad hoc* county boundaries mediation committees. The Bill proposes that a county boundaries mediation committee may be established by the President, with the approval of the Senate, when —

- (a) a county government, whose boundaries are in dispute, requests the Senate, and the Senate passes a resolution for the establishment of a county boundaries mediation committee; or
- (b) the Senate considers a petition for alteration of the boundaries of a county and resolves that mediation is the appropriate means for resolving the boundary dispute.

The composition of a county boundaries mediation committee is proposed to be as follows —

- (a) a chairperson, who shall be an advocate of the High Court of Kenya with at least fifteen years' experience in alternative dispute resolution;
- (b) one person from each of the affected counties;
- (c) two persons, one a man and one a woman, not resident in the affected county with experience in conflict management; and

(d) a public officer nominated by the cabinet secretary who shall be the secretary to the committee and an *ex-officio* member of the committee.

The committee is required, within three months, to facilitate the mediation parties to reach an agreement regarding their dispute and to report to the Senate as to whether an agreement has been arrived at between the parties. The three month period may however be extended by the President with the approval of the Senate, only once and for not more than one month.

(3) Alteration of county boundaries

The Bill provides a mechanism for alteration of county boundaries in accordance with Article 188 of the Constitution. The process commences when there is either —

- (a) an agreement to alter the boundaries of a county following a mediation process; or
- (b) a petition for the alteration of the boundaries of a county.

Where a mediation process results in an agreement for the alteration of the boundaries of a county, the President is required, within fourteen days of receipt of the mediation report, to appoint an independent county boundaries commission in accordance with the Bill.

On the other hand, a petition for the alteration of the boundaries of a county may be made, in the prescribed form, by —

- (a) any person who is a registered voter in a county whose boundary is proposed to be altered; or
- (b) a county executive committee member on behalf of a county government that proposes the alteration of its boundary.

A petition made by a registered voter shall be required to be supported by at least fifteen percent (15%) of the registered voters of the petitioner's county. The petition is not admissible by the Senate where a general election is scheduled to be held within twelve months of the date of submission of the petition to the Senate.

Where both Houses concur that an independent county boundaries commission should be established, the President is required to appoint members to the Commission, with the approval of both Houses of Parliament, in accordance with the Bill.

(4) An Independent County Boundaries Commission

Under the Bill, an Independent County Boundaries Commission comprises —

- (a) a chairperson nominated by the President;
- (b) one commissioner of the Independent Electoral and Boundaries Commission, nominated by the President;
- (c) one commissioner of the National Land Commission, nominated by the President;
- (d) two persons, one a man and one a woman, nominated by the Council of County Governors who are not residents of the affected counties;
- (e) two persons, one a man and one a woman, who are licensed surveyors under the Survey Act and who are not resident in the affected counties, nominated by the Land Surveyors' Board;
- (f) the secretary to the commission who shall be a public officer nominated by the cabinet secretary and who shall be an *ex-officio* member and not have a right to vote.

(5) Inquiry and Report of the Commission

The Bill provides for the procedure for the inquiry and report of a commission. It provides that upon receipt of a petition, the Commission is required to inquire into the petition and develop a preliminary report. The preliminary report is then to be subjected to two weeks of public participation.

Upon the expiry of the two weeks, the commission has another two weeks to review the preliminary report taking into account the views received from the public on the preliminary report and to submit a final report to the Speaker of the Senate either-

- (a) recommending the alteration of the boundaries of a county in terms of Article 188 of the Constitution; or
- (b) making such other recommendation as the commission may consider appropriate.

If both Houses approve the recommendations of the commission, the boundaries of the affected counties shall be altered in accordance with the recommendations of the commission. If a resolution for the alteration of the boundaries of a county is passed less than twelve months before a general election, the alteration of boundaries shall take effect after that general election.

THAT clause 7 of the Bill be amended by inserting the following new paragraph immediately after paragraph (c) —

(ca) submission of a petition to Parliament by any person who is a registered voter in a county whose boundary is disputed;

CLAUSE 9

THAT clause 9 of the Bill be amended -

(a) deleting the marginal note and substituting therefor the following new marginal note —

Composition of the mediation committee.

- (b) in subsection (1) by deleting paragraph (b) and substituting therefor the following new paragraph
 - (b) the county executive committee member for the time being responsible for matters related to land and physical planning in the county;
- (c) in subsection (2) by deleting the words "in the last ten years" appearing immediately after the words "affected counties" and substituting therefor the words "in the last five years";

CLAUSE 12

THAT clause 12 of the Bill be amended by inserting the following new subsection immediately after subsection (2)—

(2a) The officers referred to under subsection (1) shall include officers with knowledge and at least five years experience in physical planning and land survey.

CLAUSE 15

THAT clause 15 of the Bill be amended by deleting the introductory phrase and substituting therefor the following new introductory phrase —

The mediation committee shall, within three months of the constitution of the committee, report to the Senate on —

CLAUSE 25

THAT clause 25 of the Bill be amended —

- (a) in subsection (1) by deleting the words "nominated by the President" appearing at the end of the paragraph and substituting therefor the words "nominated by the Commission" in paragraph (b);
- (b) in subsection (1) by deleting the words "nominated by the President" appearing at the end of the paragraph and substituting therefor the words "nominated by the Commission" in paragraph (c);
- (c) by inserting the following new paragraph immediately after paragraph (c)
 - (ca) the Principal Secretary for the time being responsible for matters related to land and physical planning or a representative of the Principal Secretary designated in writing;

CLAUSE 40

THAT clause 40 of the Bill be amended in subsection (2a) by deleting the words "the county gazette" appearing at the beginning of the paragraph and substituting therefor the words "the Kenya Gazette and the county Gazette," in subparagraph (ii); deleting paragraph (b) and substituting therefor the following new paragraph—

(c) the county executive committee member for the time being responsible for matters related to land and physical planning in the county;

CLAUSE 42

THAT the Bill be amended by inserting the following new section immediately after the proposed section 42 —

Concurrence by Parliament on alteration of a boundary.

- **42A**. (1) If the National Assembly rejects the resolution of the Senate submitted under subsection (3), the resolution shall be referred to a Joint Committee of both Houses of Parliament.
- (2) The provisions of the standing orders of both Houses of Parliament on joint committees shall, with necessary modifications, apply to the process of concurrence by Parliament on alteration of a boundary.

CLAUSE 43

THAT clause 43 of the Bill be amended by deleting subsection (2) and substituting therefor the following new subsection —

(2) In making regulations under this Act, the cabinet secretary shall consult the Independent Electoral and Boundaries Commission and the county governments.

CLAUSE 2

THAT clause 2 of the Bill be amended by —

- (a) deleting the interpretation of the word "cabinet secretary"; and substituting therefor the following new interpretation "cabinet secretary" means the cabinet secretary for the time being responsible for matters related to land and physical planning;
- (b) deleting the interpretation of the word "county executive committee member"; and substituting therefor the following new interpretation "county executive committee member" means the county executive committee member for the time being responsible for matters related to land and physical planning in the county;
- (c) inserting the following new definition in the proper alphabetical sequence-

"dispute" means disagreements between two or more neighbouring counties over the possession or control of land bordering the two or more neighbouring counties;

This group noted that the boundaries of Meru and Isiolo Counties were very contentious, emotive and sensitive. They presented a memorandum and documents (including Court rulings) on the matter and requested the Committee to give consideration to the plea of Isiolo Community when looking at the County Boundaries Bill, 2018. They also noted that development projects in the contested boundaries such as LAPSSET Corridor development project (among others in the area) may be affected if the matter is not well addressed. The group further noted the need to amend the Constitution to consider historical boundaries dating way back into 1963 since the 1991 boundaries recognized in the Constitution presented overlaps and marginalization in some Counties.

Mr. Martin Simotwo: Presented a memorandum on the County boundaries bill, 2017.

(3) Africa Art Group

Mr. Wanjohi Nyamu made oral presentation to the Committee. He explained the need to respect Independent Commissions such as IEBC in undertaking their constitutional mandates. He also noted the need to consider reviewing the Constitution.

PREFACE

Establishment of the Committee

The Standing Committee on Devolution and Intergovernmental Relations is established pursuant to the Senate Standing Order (S.O.) 212. EXECUTIVE SUMMARY

The County Governments (Amendment) (No.2) Bill, 2017 (Senate Bills No. 7 of 2017) was read a First Time in the Senate on 29th November, 2017.

Following the First Reading of the Bill, it stood committed to the Committee on Devolution and Intergovernmental Relations (in accordance with Standing Order 134) for facilitation of public participation and consideration. Consequently, the Committee, pursuant to Article 118 of the Constitution and Standing Order 134 (5), invited submissions from members of the public on the above Bills via an advertisement on the Daily Nation Newspaper on Tuesday, 27th February, 2018. The Committee received both oral and written submissions on the Bills during its meetings with the members of public held on 28th February, 2018 in the Commission Board Room, First Floor, County Hall, Parliament Buildings, on 6th March 2018 in Committee Room 10, Parliament Buildings and on 8th March, 2018 in Committee Room 9, Parliament Buildings.

CHAPTER ONE

1. INTRODUCTION

1.1. The County Governments (Amendment) (No.2) Bill, 2017 (Senate Bills No. 7 of 2017)

The County Governments (Amendment) (No.2) Bill, 2017 (Senate Bills No. 7 of 2017) is sponsored by Sen. Mutula Kilonzo Junior, MP. The Bill seeks to amend the County Governments Act, No. 17 of 2012 to provide for the procedure for the disposal of a report of a Commission of Inquiry established pursuant to Article 192(2) of the Constitution. Further, the Bill seeks to provide for the termination of a suspension of a county government under Article 192(4) of the Constitution.

OVERVIEW OF THE BILL

1.2. The County Governments (Amendment) (No.2) Bill, 2017 (Senate Bills No. 7 of 2017)

The Bill seeks to amend Section 123(7) of the Act to provide that the Commission shall inquire into the matters before it within three (3) months of its appointment and report on the facts and submit its recommendations to the President. Currently, there are no timelines and the Commission is only required to inquire into matters before it expeditiously. Thereafter, within seven days of receipt of the report of the Commission, the President is expected to submit to the Speaker of the Senate the report, the recommendations of the Commission and the petition.

Where the President, in the memorandum submitted is satisfied that justifiable grounds exist for the suspension of a county government, the Speaker of the Senate shall refer the documents received to the relevant Senate Committee for consideration. The committee has fourteen days to consider the documents and make its recommendations to the Senate on whether or not the Senate should authorize the suspension. The Bill makes provision

for a situation where the Commission does not recommend the suspension of a county government or where the President is not satisfied that justifiable grounds exist for suspension. In such an instance, the Senate may consider any other recommendations of the Commission not relating to whether or not the county government should be suspended and make a determination on the way forward with respect to those recommendations.

The Bill also seeks to provide for the procedure for the termination of a suspension of a county government by the Senate as the procedure is currently not provided for in the Act. The Bill provides that a Senator may move a motion for the termination of a suspension of a county government. The Speaker shall refer the proposed motion to the relevant select committee of the Senate to consider and make recommendations as to whether or not the Senate should terminate the suspension of a county government. The committee shall report to the Senate within ten days of referral of the motion to the committee and shall invite representations from the public, the Interim County Management Board and any other relevant person.

The report of the committee shall be tabled in the Senate and if the motion is supported by a majority of all the county delegations of the Senate, the suspension of the county government shall stand terminated. On termination of suspension of a county government-

- (a) the Interim County Management Board shall stand dissolved; and
- (b) the governor, the deputy governor and the members of the county executive committee, the speaker and the members of the county assembly shall resume their functions and continue to receive their benefits in full from the date of termination of the suspension and shall hold office for the remainder of their term.
